Sir,

In producing here with the one arrested accused person namely Keshab Chettri ((53 yrs) S/o Lt. Tek Bahadur Chettri og Limbu Busty, Near Parijat Club, PS- Bhakti Nagar, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

- 1] Twelve (12) Bottles of Kingfisher strong premium beer (each bottle containing 650 ML.)
- 2] Nine (9) bottles of Himalayan Gold Country Spirit 60 UP (each bottle containing 600 ml.)

I, ASI Dipak Karmakar of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person to the effect that on 30.06.2022 at about 18.15 hrs received a source information that the above noted accused person has possessed huge amount of liquor in his hotel style as Bhouju Hotel at Near Checkpost under Bhaktinagar PS for selling the same to local customers. This refers to Bhaktinagar PS GDE No. 1552 Date: 30/06/22. Accordingly the information shared before you and as per your kind direction I along with force of Bhaktinagar PS left PS to work out the information. At about 18.25 Hrs we reached at Bhouju Hotel and as shown and being identified by the source held raid at the aforesaid hotel and apprehend one person who disclosed his name and address as noted above. Further maintaining his decency and observing all formalities searched inside the hotel and recovered huge amount of above noted seized liquor. On demand of license and documents in respect of possessing the liquor he failed to produce the same. On enquiry the apprehended accused person admitted his guilt and confessed that he has possessed above noted liquor for the purpose of selling to his designed customers for his wrongful gain. He also stated that he has been doing this act illegally since long without any valid licence or Documents for his wrongful gain. Accordingly, I prepared seizure list of the above noted articles in presence of witnesses duly sign by the accused as well as witnesses. The seizure made between 18.45 hrs to 19.20 Hrs. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C apprising him the ground of arrest.

I, therefore pray before your kind honour that a specific case may kindly be registered against the accused person namely Keshab Chettri ((53 yrs) S/o Lt. Tek Bahadur Chettri og Limbu Busty, Near Parijat Club, PS- Bhakti Nagar, Dist- Jalpaiguri under proper section of law and arrange for its investigation.
