I, Aniljit Karimakar, S/O Alok Karimakar resident of Adya villa, Ashrampara, Near - Rajib More, Siliguri and ALSO resident of Anabindanagar, Alipindum would like to state you that last night i.e, 29/06/2022 at around 9:30 pm I along with my wife Smt. Debalina Guha (Karimakar) were returning to our home via Chayanpara More to Ashrampara from Ashghar that Chayanpara more one four wheeler (Hoodless Jeep bearing registration NO - NL05E 1663 coming from opposite direction rashly and negligently hit us and fled away. The driver was fully intoxicated and started to misbehave with us using filthy languages. Due to rash and negligent and drunk driving of driver of the vehicle Reg NO - NL05E1663 the accident took place and as a result we got hurt. Seriously and my wife got leg injury. That there after immediately I took my wife to the nearest nursing home named Basus clinic and admitted her to the Emergency ward. After X-Ray and initial checkup the doctor treated my wife and found that she got ligament injury of (RT) ankle and foot following trauma to foot and prescribed medicines accordingly.
