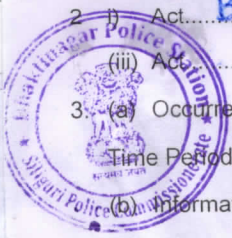

Sir,

In producing herewith one accused person namely (1) Katim Roy (52), S/O-Late Dhania Roy of Ektiasal Near Kali Mandir PS Bhaktinagar Dist. Jalpaiguri and the following articles under seizure:

- (1) 12 (Twelve) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.120/- (Total- 7.2 Liter & Amount Rs 1440/-).

I SI Pradip Kr Singha of Ashighar OP PS Bhaktinagar lodged a written complaint against the accused person namely (1) Katim Roy (52), S/O-Late Dhania Roy of Ektiasal Near Kali Mandir PS Bhaktinagar Dist. Jalpaiguri to the effect that, today i.e 02.07.2022 evening as per order of O/C Ashighar OP I along with ASI Amit Mallick C/ 877 Munna Ahmed and CV/1016 Amrit Roy , all of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashigharh OP as per order vide Ashighar OP GDE no. 37 Dt 02.07.2022 in course of which I received information from my source that one Katim Roy stored a huge numbers of bottles of liquor inside his house at Ektiasal Near Kali Mandir and used to sell to the local youth in higher rates. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Ektiasal Near Kali Mandir area to verify the veracity of information. On the way I called two local person namely (1) Dilip Das (37) S/O Kali Charan Das of Ghugumali PS Bhaktinager Dist Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Niranjan nagar W/no. 36 PS Bhaktinager Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Ektiasal Near Kali Mandir area as indicated by my source I held raid at the house of Katim Roy at Ektiasal Near Kali Mandir .But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside his house . I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 17.20 hrs and 17.45 hrs on 02.07.2022

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused person namely (1) Katim Roy (52), S/O-Late Dhania Roy of Ektiasal Near Kali Mandir PS Bhaktinagar Dist. Jalpaiguri and arrange for its investigation.
