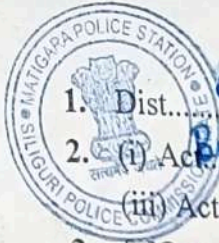

In producing herewith one accused person named Shyamal Basak (65 yrs) S/O Mahendra Basak of B.S. Dhaba, Near Bharat Petrol Pump, PS- Matigara, Dist.- Darjeeling along with following articles under proper seizure list :-

(i) 12 (Twelve) bottles of 'Himalayan Gold 60 UP' Country Spirit containing 600 MI in each bottle and value of Rs 120/- of each bottle and marked as "Exhibit- "A" out of which 01 (One) bottle taken as sample for examination and marked as "Exhibit A-1".


I, SI Uday Chakraborty of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person namely Shyamal Basak (65 yrs) S/O Mahendra Basak of B.S. Dhaba, Near Bharat Petrol Pump, PS- Matigara, Dist.- Darjeeling to the effect that on 02.07.2022 at 18.55 hrs received a source information that one person named Shyamal Basak of B.S. Dhaba under PS - Matigara, Dist.- Darjeeling is selling liquor at his Dhaba at near Bharat Petrol Pump, Matigara without any valid license. Accordingly, the fact was diarized in General Diary vide Matigara PS GDE No 102 Dated 02.07.2022 and shared the information with O/C Matigara PS and as per his kind order and direction myself along with force had been to B.S Dhaba, Matigara to verify the veracity of the information in hand. On reaching there and as identified by the source we held raid at the B.S Dhaba near Bharat Petrol Pump, Matigara and managed to apprehended him. On being asked he disclosed his identity as noted above and disclosed that he is selling illicit liquor in his Dhaba without any license for his wrongful gain. Further being searched the above noted seized articles were recovered from the said Dhaba. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above mentioned accused person named Shyamal Basak (65 yrs) S/O Mahendra Basak of B.S. Dhaba, Near Bharat Petrol Pump, PS- Matigara, Dist.- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 02.07.22 in between 19.55 hrs to 20.40 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against arrested accused namely Shyamal Basak (65 yrs) S/O Mahendra Basak of B.S. Dhaba, Near Bharat Petrol Pump, PS- Matigara, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.


