**Subject: FIR**

Sir,

In producing herewith three (03) arrested accused persons namely (i) Pradip Biswas (34yrs) S/o- Lt. Narsh Biswas of Jalpaimore, Ramghat, W/no-05, PS- Siliguri, Dist- Darjeeling, (ii) Sanjit Haldar(35yrs) S/o- Lt. Paresh Haldar of Surya Sen Colony, block- 2, PS- NJP, Dist- Jalpaiguri, (iii) Biswajit Haldar(19yrs) S/o- Dayal Haldar of Hatiyadanga, Chandan Nagar, PS- Bhaktinagar, Dist- Jalpaiguri arrested u/s- 41 Cr.P.C along with following seized articles viz:

1. One (01) iron made sword measuring 23 inch (approx) including wooden butt from the possession of Pradip Biswas which was kept concealed on his back side
2. One (01) iron made crowbar measuring 17 inch (approx) from the possession of Sanjit Haldar which was kept on his right hand
3. One (01) iron made sabol measuring 18 inch (approx) from the possession of Biswajit Haldar which was kept at his left hand

I, PSI Sumit Rawat of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely i) Pradip Biswas, (ii) Sanjit Haldar, (iii) Biswajit Haldar and others namely Raja, Bikki, Md. Bappa to the effect that today on 01.07.2022 at 00.25 hrs received a sources information that 12/13 persons have assembled at the backside of Polytechnic College, Dabgram under Siliguri PS with a view to commit dacoity at Dabgram area. The fact was diarized in GD vide Siliguri PS GDE No- 03 dated 01.07.2022. Subsequently, after sharing the information with I/C Siliguri PS and as per his direction, I along with ASI Siben Sarkar, ASI- Rabin Lama, ASI Debasish Das, C/1048 Gopal Roy, CV/283 Prasenjit Dey, CV/622 Ramanath Barman left for the place to work out the information. At about 01.05 hrs after reaching near Polytechnic College, Dabgram I met my source and being pointed by the source we started walking towards backside of Polytechnic College, Dabgram. After reaching backside of Polytechnic College, Dabgram started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from the spot seeing police personnel approaching towards them. They tried to flee away but on hot chase we managed to apprehend above noted three (03) accused persons along with seized articles as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Dabgram area.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 01.45 hrs to 02.15 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized article at Siliguri Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house at Dabgram area. It is also revealed from them that some others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (i) Pradip Biswas (34yrs) S/o- Lt. Naresh Biswas of Jalpaimore, Ramghat, W/no-05, PS- Siliguri, Dist- Darjeeling. (ii) Sanjit Halder(35yrs) S/o- Lt. Paresh Halder of Surya Sen Colony, block- 2, PS- N.JP, Dist- Jalpaiguri, (iii) Bijoy Halder(19yrs) S/o- Dayal Halder of Hatiyadanga, Chandan Nagar, PS- Bhaktinagar, Dist- Jalpaiguri and others namely Raja, Bikki, Md. Bappa and arrange for its investigation.
