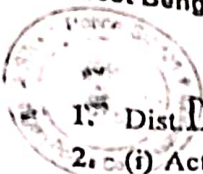

We would like to inform you that we had taken on rent office premises with godown (godown for storing of our garden tea in transit) at 'More Bhawan', Burdwan Road, Siliguri, PIN: 734 405 from one 'More Family' in the year 1968 and since then our office and godown is functioning at the same place. But due to Covid pandemic and the sudden demise of our Siliguri Branch Manager, Late R.A. Sharma the said office was not in operation since April, 2020.

Yesterday, i.e. on 29.06.2022 we deputed our office representative Mr. Ranjit Yadav to Siliguri to restart the operation of our office & godown at the above place but when he entered the premises, surprisingly, he found that a construction work is going on at the other side of the same premises and all our office papers, furnitures, computers, samples of tea etc. are stolen/missing and the windows and doors of the office has also been broken/taken away.

Today morning around 10:00 A.M. when our representative Mr. Ranjit Yadav visited the premises along with 3-4 workers to clean the office & godown to make it in working condition, one person (Bunty Babu) from outside the premises came to the premises around 12.30 noon and asked the identity of our representative and told our representative that the property belongs to his brother and he then left the place. After 10/15 minutes he came back again along with some other 3-4 people came directed our representative Mr. Yadav to vacate and leave the place immediately. At around 3.30 P.M. the said Bunty Babu along with some 4-5 ladies and 15-20 persons came and used filthy languages against our representative and threatened him with dire consequences and physically pushed him away from the premises and also told our representative that if he came back again he will face dire consequences. They have also taken away the name plates of our company.

This is for your kind information and taking necessary steps so that we can peacefully function the operations of our office at the above place. Kindly also make an F.I.R. and stop the construction work at our office premises and allow us to function our office and godown smoothly.
