Sir,

In producing here with the one arrested accused Sanjib Biswas(28yrs) S/o- Lt. Pradip Biswas of Suryasen Colony, Block- D W/no- 33, PS- NJP, Dist- Jalpaiguri, C/O- Rano Das S/o- Lt. Anil Chandra Das of Debasish colony near Radha Krishna Mandir, W/no- 24, PS- Siliguri, Dist- Darjeeling along with Seventeen (17) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value Rs 120/- X 17 = Rs 2040/-)

I ASI Rabin Lama of Siliguri PS under Siliguri Police Commissionerate do here by lodge a written complaint against the arrested accused person namely Sanjib Biswas(28yrs) S/o- Lt. Pradip Biswas of Suryasen Colony, Block- D W/no- 33, PS- NJP, Dist- Jalpaiguri, C/O- Rana Das S/o- Lt. Anil Chandra Das of Debasish colony, near Radha Krishna Mandir, W/no- 24, PS- Siliguri, Dist- Darjeeling to the effect that on 01/07/2022 during my mobile van duty (vide Siliguri PS GDE no 41 dated 01/07/2022) I received a source information at about 16.15 hrs from Debasish colony, ward no 24 under Siliguri PS. that one Sanjib Biswas of Suryasen Colony presently residing at the house of his in- laws namely Rano Das S/o- Lt. Anil Chandra Das of Debasish Colony W/no- 24 is selling huge quantity of liquor illegally in his in- laws house to his design customers since long, for his wrongful gain. After sharing the information with 1/C Siliguri and as per his kind direction, I along with ASI Debasish Das, ASI Siben Sarkar, CV/263 Prasenjit Dey proceeded to the P.O to work out the source information. At about 16.25 hrs I along with my police team reached Debasish Colony, W/no-24, on being identified by the source our police team held raid in the house of Rano Das and managed to apprehended one Sanjib Biswas, and recovered Seventeen (17) bottles of Himalayan gold 60 up country spirit each bottle containing 600 ml, from the possession of Sanjib Biswas. On interrogation he disclosed his identification as Sanjib Biswas(28yrs) S/o- Lt. Pradip Biswas of Suryasen Colony, Block- D W/no- 33, PS- NJP, Dist- Jalpaiguri, C/O- Rano Das of Debasish colony, W/no- 24, PS- Siliguri, Dist- Darjeeling along with Seventeen (17) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. and he admitted that he sell the same to his design customers since long for his wrongful gain. On demand he failed to produce any valid documents or licence in r/o said liquor, accordingly I seized the same viz; Seventeen (17) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml (Total market value Rs 120 X 17 = Rs 2040/-) from the possession of Dipak Biswas (47 yrs) s/o- late Asutosh Biswas of Sarbahara Colony, Chittaranjan road, ward no 28 PS- Siliguri Dist- Darjeeling (seizure and labelled was made between 16.40 hrs to 17.15 hrs) in presence of witnesses duly sign by the accused as well as witnesses. As he violated the rules and norms of Bengal Excise Act, as such I arrested him u/s 41 Cr.P.C appraise him ground of arrest and issued arrest memo in presence of witnesses.

I, therefore pray before your kind honour to take legal action against the arrested Sanjib Biswas(28yrs) S/o- Lt. Pradip Biswas of Suryasen Colony, Block- D W/no- 33, PS- NJP, Dist- Jalpaiguri, C/O- Rano Das S/o- Lt. Anil Chandra Das of Debasish colony near Radha Krishna Mandir, W/no- 24, PS- Siliguri, Dist- Darjeeling under proper section of law.
