I, **SRI. RANJAN GOSWAMI**, son of Late Upendra Goswami, Hindu by religion, business by occupation, resident of C/o. Late Upendra Goswami, P.O. Sawkuchi, Guwahati, Police Station Fatashil Ambari, PIN 781034, in the State of Assam, wish to inform you that I am the lawful owner of a plot of land measuring 3 (three) kathas, morefully described in the Schedule given below, by virtue of my purchase vide a registered Deed of Conveyance, being No. I-145 for the year 2015 (dated 21.01.2015) which was registered in the Addl. District Sub-Registry Office at Siliguri. As I am a permanent resident of Assam, it was quite impossible for me to look after the land regularly, therefore I appointed one Sri. Partha Dey, son of Sri. Bibhuti Dey of Deshandhu Para, Ward No. 30 of S.M.C., P.O. & P.S. Siliguri, District Darjeeling as my true and lawful Constituted Attorney by virtue of a registered General Power of Attorney being No. IV-420 for the year 2016, registered in the Office of the Addl. District Sub-Registrar, Siliguri. On my last visit to Siliguri on 02.01.2022, I visited my said land but to my utter surprise I found that my aforesaid Attorney, Sri. Partha Dey constructed one tin shaded room in my aforesaid land wherefrom he has been running his business of Rod Iron, Cement etc. When I asked him that how could he do so without my permission he became furious and started abusing me with flirty languages and claimed himself as the owner of the that land and he also threatened me with dire consequences if I dared to resist him in any manner whatsoever. I was compelled to leave the place in the face of such threats and on the same date as I had a return ticket to Assam, I could not think what to do next. Thereafter, I executed one registered revocation of general power of attorney on 10.02.2022, being No. IV-25 of 2022, registered in the Office of the Addl. District Sub-Registrar, Siliguri whereby I cancelled the General Power of Attorney being No. IV-420 of 2016 and removed the name of Sri. Partha Dey from my Constituted Attorney and it was duly communicated to him through my Lawyer Mr. Shoubhik Saha by a Lawyer Notice dated 17.03.2022, send though registered post. Apart from

that paper publication was made in two local news papers disclosing the fact of revocation of my aforesaid general power of attorney.

Sir, I have come to learn that said Sri. Partha Dey is a very dangerous person and he has a very good contact with political leaders and I further apprehended that said Sri. Partha Dey may even illegally sell or otherwise deliver possession of my said land to others by manufacturing false land documents.

I would request you to kindly inquire into the matter immediately so that no harm is caused to my below schedule landed property by Sri. Partha Dey. I would also request you to take appropriate legal action against the Sri. Partha Dey for indulging in such illegal and nefarious activity.

All that piece and parcel of homestead land measuring 3 kathas, recorded in R.S. Khatian No. 2664, comprised in R.S. Plot No. 11860/13148, under Mouza Siliguri, within Pargana Baikunthapur, J.L. No. 110(88), Police Station, Sub-Division and Addl. District Sub-Registry Office Siliguri, under Ward No. 30 of Siliguri Municipal Corporation, District Darjeeling, in the State of West Bengal.

My said land is butted and bounded as follows:

South: Land of Harish Lal Roy;

East : Land and house of Santi Ranjan Bhaduri;

West : 19 feet wide S.M.C. Road.
