LPSI Sumit Rawat of Siliguri PS under Siliguri Police Commissionerate do here by lodge a written complaint against the arrested accused person namely Sabita Haldar(35yrs) W/o- Dayal Haldar of Hativadanga, Chandan Nagar, PS- Bhaktinagar, Dist- Jalpaiguri to the effect that on 02/07/2022 during my PC mobile van duty (vide Siliguri PS GDE no-80 dated 02/07/2022) I received a source information at about 08:55 hrs from Court more under Siliguri PS that one Smt Sabita Haldar is selling huge quantity of liquor illegally in near Treasury Building to her design customers since long, for her wrongful gain. After received the information myself along with. ASI Siben Sarkar, LC/493 Parul Chakraborty. LCV/176 Parbati Barman, CV/ Ramanath Barman proceeded to the P.O to work out the source information, at about 09.15 hrs I along with my police team reached at Court more and, on being identified by the source our police team managed to apprehended the said person with the help of lady forces and recovered Fifteen (15) bottles of Himalayan gold 60 up country spirit each bottle containing 600 ml, which was containing in a white colour plastic Bag. On interrogation she disclosed her identification as Sabita Haldar(35yrs) W/o- Dayal Haldar of Hatiyadanga, Chandan Nagar, PS-Bhaktmagar, Dist- Jalpaiguri and she admitted that she sell the same to her design customers since long for her wrongful gain. On demand she failed to produce any valid documents or licence in t/o said liquor. accordingly I seized the same viz 1. Fifteen (15) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml (Total market value RS/- 120 X 15 = Rs 1800/-) from the possession of Sabita Haldar(35yrs) W/o- Dayal Haldar of Hatiyadanga, Chandan Nagar, PS- Bhaktinagar, Dist- Jalpaiguri (seizure and labelled was made between 09:35 hrs to 10.05 hrs) in presence of witnesses duly sign by the accused as well as witnesses. As she violated the rules and norms of Bengal Excise Act, as such I arrested her with the help of LC/493 Parul Chakraborty u/s 41 Cr.P.C appraise her ground of arrest and issued arrest memo in presence of witnesses.

I. therefore pray before your kind honour to take legal action against the arrested Smt Sabita Haldar(35yrs) W/o- Dayal Haldar of Hatiyadanga, Chandan Nagar, PS- Bhaktinagar, Dist- Jalpaiguri under proper section of law.
