Sir,

In producing here with the one arrested accused person namely Asraful Rahoman(24) S/O- Habibul Rahoman of Tikia Para Ward No- 28 PS- Siliguri Dist- Darjeeling, along with the following seized articles as per proper seizure list:

1. Twelve Bottle (12) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value RS/- 120 X 12 = 1440/-)

I ASI Debasish Das of Siliguri PS under Siliguri Police Commissionerate do here by lodge a written complaint against the above noted arrested accused person namely Rahoman to the effect that on 02/07/2022 at about 08:45 hrs during my PC mobile van duty (vide Siliguri PS GDE no-79 dated 02/07/2022) I received a source information from Tikiapara, ward no 28 under Siliguri PS that one person namely Asraful Rahoman of Tikiapara, Matangini- I, he selling huge quantity of liquor illegally at Tikiapara ward no 28 in his tea shop to his design customers since long, for his wrongful gain. After received the information myself along with, ASI Rabin lama CV/ Prosenjit Dey, CV/ Ramanath Barman proceeded to the P.O to work out the source information, at about 09:05 hrs I along with my police team reached at Tikiapara Matangini- 01, ward no 28 and, on being identified by the source our police team held raid in the tea shop of Asraful Rahoman and managed to apprehended the said person and recovered twelve (12) bottles of Himalayan gold 60 up country spirit each bottle containing 600 ml, from his tea shop. On interrogation he disclosed his identification as Asraful Rahoman(24) S/O- Habibul Rahoman of Tikia Para Ward No- 28 PS- Siliguri Dist- Darjeeling, and he admitted that he sell the same to his design customers from since long for his wrongful gain. On demand he failed to produce any valid documents or licence in r/o said liquor, accordingly I seized labelled was made between 09.15 hrs to 09:45 hrs in presence of witnesses duly sign by the accused as well as witnesses. As he violated the rules and norms of Bengal Excise Act, as such I arrested him u/s 41 Cr.P.C appraise him the ground of arrest and issued arrest memo in presence of witnesses.

I, therefore pray before your kind honour to take legal action against the arrested person namely Asraful Rahoman(24) S/O- Habibul Rahoman of Tikia Para Ward No- 28 PS- Siliguri Dist- Darjeeling, under proper section of law.
