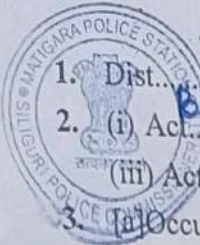

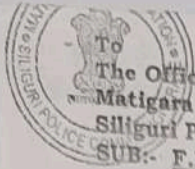

Sir,

In producing herewith one accused person named Rupu Barman (30 yrs) W/O Bijoy Barman of Biswas Colony, Sutki Godwn, PS- Matigara, Dist.- Darjeeling along with following articles under proper seizure list :-


- (i) 13 (Thirteen) bottles of Himalayan Gold 60 UP' Country Spirit containing 600 MI in each bottle and value of Rs 120/- of each bottle and marked as "Exhibit- "A" out of which 01 (One) bottle taken as sample for examination and marked as "Exhibit A-1".
- (ii) 26 (Twenty six) bottles of KINGFISHER STRONG PREMIUM BEER containing 650 MI in each bottle and value of Rs 120/- of each bottle and marked as "Exhibit- "B" out of which 01 (One) bottle taken as sample for examination and marked as "Exhibit B-1".
- (iii) one plastic container (Jarican) containing total 10 litre of local made Chullu and marked as "Exhibit-C" out of which 500 ml of Chullu taken in a plastic bottle for examination and marked as "Exhibit-C-1".

I, SI Uday Chakraborty of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person namely Rupu Barman (30 yrs) W/O Bijoy Barman of Biswas Colony, Sutki Godwn, PS- Matigara, Dist.- Darjeeling to the effect that on 03.07.2022 at 16.05 hrs received a source information that one lady namely Rupa Barman of Biswas Colony, near Sutki godwn under PS - Matigara, Dist.- Darjeeling is selling liquor at her residence since long without any valid documents. Accordingly, the fact was diarized in General Diary vide Matigara PS GDE No 149 Dated 03.07.2022 and shared the information with O/C Matigara PS and as per his kind order and direction myself along with force and LC/1251 Yankila Bhutia and LC/1286 Anisha Chhetri both of Matigara PS left for Biswas Colony near Sutki Godwn to verify the veracity of the information in hand. On reaching there and as identified by the source we held raid at the residence of accused Rupu Barman at Biswas Colony, Sutki Godwn, PS- Matigara, Dist.- Darjeeling and managed to apprehended her by the lady force. On being asked she disclosed her identity as noted above and disclosed that she is selling illicit liquor in her residence for her wrongful gain. Further being searched the above noted seized articles were recovered from the residence of the above noted accused. On demand she failed to produce any valid license/papers for selling and storing of such articles. On further interrogation in presence of lady force she stated that she is involved in selling and possessing of liquor without any valid license for last few months for her illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above mentioned accused person named Rupu Barman (30 yrs) W/O Bijoy Barman of Biswas Colony, Sutki Godwn, PS- Matigara, Dist.- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 03.07.22 in between 16.45 hrs to 17.40 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against arrested accused namely Rupu Barman (30 yrs) W/O Bijoy Barman of Biswas Colony, Sutki Godwn, PS- Matigara, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
