Sir,

In producing herewith the seized 10 (Ten) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.120/- (Total-6 Liter & Amount Rs 1200/-) and lodged a written complaint against the lady accused person namely Smt Urmila Debnath (55) W/O Late Sunil Debnath of Jaleshwari bazaar Mahim Coloney PS Bhaktinagar Dist Jalpaiguri.

I SI Pradip Kr Singha of Ashighar OP lodged a written complaint against the accused person Smt Urmila Debnath (55) W/O Late Sunil Debnath of Jaleshwari bazaar Mahim Coloney PS Bhaktinagar Dist Jalpaiguri to the effect that, today i.e 03.07.2022 evening as per order of O/C Ashighar OP I along with ASI Sumit Baran Nath C/877 Munna Ahmed ,L/C 1234 Hira Roy and CV/1016 Amrit Roy , all of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashigharh OP as per order vide Ashighar OP GDE no. 64 Dt 03.07.2022 in course of which I received information from my source that one Urmila Debnath stored a huge numbers of bottles liquor inside her house at Jaleshwari bazaar Mahim Coloney and used to sell to the local youth in higher rates. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Jaleshwari bazaar Mahim Coloney area to verify the veracity of information. On the way I called two local person namely (1) Dilip Ghosh (37) S/O Kali Charan Ghosh of Ghugumali PS Bhaktinagar Dist Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Niranjana Nagar W/no.36 PS Bhaktinagar Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Jaleshwari bazaar Mahim Coloney area as indicated by my source I held raid at the house of Urmila Debnath at Jaleshwari bazaar Mahim Coloney . But the lady accused person managed to escape from the spot. I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside her house. I seized the above noted articles as alamath of the case, as none could be able to produce any documents for such illegal possession of such articles. During enquiry I came to know the name and address of lady accused person is noted above. The Search and seizure were made in between 16.35 hrs and 16.55 hrs on 03.07.2022.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused person Smt Urmila Debnath (55) W/O Late Sunil Debnath of Jaleshwari bazaar Mahim Coloney PS Bhaktinagar Dist Jalpaiguri and arrange for its investigation.
