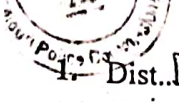

Sir,

In producing herewith one arrested accused person namely Jatin Gowala (19) S/O Chandan Gowala of Zanjupara, Kismat Sukhani, Fatapukur, PS- Rajganj, Dist- Jalpaiguri along with the seized articles as per seizure list:-

1. One improvised iron made fire Arms (Pistol) in working condition measuring approx 9" inches from barrel to butt having striking pin, hammer and trigger.
2. One piece Gold Lamp.
3. One piece Silver Lamp.
4. Cash Rs. 17000/-.

I SI Ashim Kumar Das of Panitanki TOP under Siliguri Police Station, Siliguri Police Commissionerate do hereby lodge this complaint that today on 02/07/22 around 05:35 hrs, I received a secret source information that one of the wanted criminal of crime against property namely Jatin Gowala (19) S/O Chandan Gowala of Zanjupara, Kismat Sukhani, Fatapukur, PS- Rajganj, Dist- Jalpaiguri is roaming at Khudiram Pally area under Siliguri PS with an ulterior motive and is in possession of firearm. Diarised the matter in Panitanki TOP vide Panitanki TOP GD entry no-18 dated 02/07/22. Then at 06:15 hrs as per kind instruction of OC Panitanki TOP I along with ASI Surajit Mallick, ASI Biswajit Ghosh, ASI Biswajit Saha, C/984 Subhasish Das, C/1036 Gopal Srivastav and CV-1009 Manoj Thakur all of Panitanki TOP under Siliguri PS took departure to workout the information. This refers Panitanki TOP GDE No-21 dated 02/07/22. At about 06:25 hrs we rushed to the spot at Khudiram Pally area under PS Siliguri and on the way we called two disinterested witnesses namely (1) Bishnu Paul (30) S/O Sri Sudip Paul of Hakimpara, Rishi Aurobinda Road, Ward No-12, PS- Siliguri, Darjeeling, and (2) Ratan Das (40) S/O Rahini Das of Heiderpara, Subhashpally, Ward No. 40, PS- Bhaktinagar, Dist- Jalpaiguri duly informing them about the information in hand. Then after arrival, as per description of the wearing apparels supplied by the source, we apprehended the person noted above with all precautionary measures. On being asked, the apprehended person disclosed his identity as Jatin Gowala (19) S/O Chandan Gowala of Zanjupara, Kismat Sukhani, Fatapukur, PS- Rajganj, Dist- Jalpaiguri.

Accordingly, as per information and following all necessary procedures of search of the Police person by the witnesses, search of the apprehended persons was made. On search One improvised iron made fire Arms (Pistol) in working condition measuring approx 9" inches from barrel to butt having striking pin, hammer and trigger, One piece Gold Lamp, One piece Silver Lamp and Cash Rs. 17000/- was recovered, which was kept concealed in his waist and other articles kept in his pocket. On being asked about the possession of the firearm and other articles, the apprehended made incoherent statements.

As there is every reason to believe that the firearm recovered has been procured dishonestly by the apprehended person and other articles noted above for his ulterior motive. Accordingly seized the firearm and other articles duly taking its measurements and details in presence of the witnesses duly signed by them and acknowledge by the apprehended person's and arrested him following all formalities. The seizure has done between 06:35 hrs to 07:25 hrs.

Under the above circumstances, I pray that a specific case under Arms Act may kindly be started against the arrested person namely Jatin Gowala (19) S/O Chandan Gowala of Zanjupara, Kismat Sukhani, Fatapukur, PS- Rajganj, Dist- Jalpaiguri and arrange for its investigation.
