Myself Navanil Mukherjee, resident of
38, Birish Ghosh Sarani, Hakimpura,
(ward No -16), want to state that, yesterday,
i.e., 01/07/2022, at around 3:20 pm,
my father, Mr. Narayan Mukherjee (72 years)
and my mother Mrs. Sumana Mukherjee
(65 years) were travelling from our residence
to Doodh More (ward No -15), a rickshaw
carrying my father and mother was hit
from behind by a speeding vehicle, near
Royal Sporting Club (ward No -15), my parents
fell down with the rickshaw in the
adjacent drain and were severely injured.
Local people rushed to the location to help
my injured parents, they were taken to
Siliguri District Hospital Emergency for
trauma care.
