Sir,

In producing here with the one lady arrested accused Mamoni Das(40yrs) W/o- Lt. Sankar Das of FCI Gate, W/no- 35, PS- NJP, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

Eight (08) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value RS/- 120 X 08 = Rs 960/-)

I PSI Sumit Rawat of Siliguri PS under Siliguri Police Commissionerate do here by lodge a written complaint against the arrested accused person namely Mamoni Das(40yrs) W/o- Lt. Sankar Das of FCI Gate, W/no- 35, PS- NJP, Dist- Jalpaiguri to the effect that on 03/07/2022 during my PC mobile van duty (vide Siliguri PS GDE no- 177 dated 03/07/2022) I received a source information at about 15:35 hrs from Jorapani, Ward no- 24 under Siliguri PS that one Smt Mamoni Das is selling huge quantity of liquor illegally in her Shop situated near Jorapani Bridge to her design customers since long, for her wrongful gain. After received the information myself along with, ASI Debasish Das, ASI Rabin Lama LC/1282 Swastika Sharma, LCV/176 Parbati Barman, CV/ Ramanath Barman proceeded to the P.O to work out the source information, at about 15.45 hrs I along with my police team reached near Jorapani Bridge, ward no- 24 and on being identified by the source our police team managed to apprehended the said person with the help of lady forces and recovered Eight (08) bottles of Himalayan gold 60 up country spirit each bottle containing 600 ml, which was containing in a white colour plastic Bag. On interrogation she disclosed her identification as Mamoni Das(40yrs) W/o- Lt. Sankar Das of FCI Gate, W/no- 35, PS- NJP, Dist- Jalpaiguri and she admitted that she sell the same to her design customers since long for her wrongful gain. On demand she failed to produce any valid documents or licence in r/o said liquor, accordingly I seized the same viz 1. Eight (08) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml (Total market value RS/- 120 X 08 = Rs 960/-) from the possession of Mamoni Das(40yrs) W/o- Lt. Sankar Das of FCI Gate, W/no- 35, PS- NJP, Dist- Jalpaiguri, (seizure and labelled was made between 15:55 hrs to 16.30 hrs) in presence of witnesses duly sign by the accused as well as witnesses. As she violated the rules and norms of Bengal Excise Act, as such I arrested her with the help of LC/1282 Swastika Sharma u/s 41 Cr.P.C appraise her ground of arrest and issued arrest memo in presence of witnesses.

I, therefore pray before your kind honour to take legal action against the arrested Mamoni Das(40yrs) W/o- Lt. Sankar Das of FCI Gate, W/no- 35, PS- NJP, Dist- Jalpaiguri under proper section of law.
