Sir,

In producing here with the one lady arrested accused Kusma Sahani(65yrs) W/o- Lt. Ram Vilas Sahani of Tikiapara, Matangini - I, W/no- 28, PS- Siliguri, Dist- Darjeeling along with the following seized articles as per proper seizure list:

Seven (07) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value RS/- 120 X 07 = Rs 840/-)

I ASI Siben Sarkar of Siliguri PS under Siliguri Police Commissionerate do here by lodge a written complaint against the arrested accused person namely Kusma Sahani(65yrs) W/o- Lt. Ram Vilas Sahani of Tikiapara, Matangini - I, W/no- 28, PS- Siliguri, Dist- Darjeeling to the effect that on 03/07/2022 during my PC mobile van duty (vide Siliguri PS GDE no- 177 dated 03/07/2022) I received a source information at about 15:00 hrs from Tikiapara, Ward no- 28 under Siliguri PS that one Smt Kusma Sahani is selling huge quantity of liquor illegally in her house at Tikiapara to her design customers since long, for her wrongful gain. After received the information myself along with, ASI Rabin Lama LC/1282 Swastika Sharma, LCV/176 Parbati Barman, CV/ Ramanath Barman proceeded to the P.O to work out the source information, at about 15.10 hrs I along with my police team reached at Tikiapara, ward no- 28 and on being identified by the source our police team managed to apprehended the said person with the help of lady forces and recovered Seven (07) bottles of Himalayan gold 60 up country spirit each bottle containing 600 ml. which was containing in a white colour plastic Bag. On interrogation she disclosed her identification as Kusma Sahani(65yrs) W/o- Lt. Ram Vilas Sahani of Tikiapara, Matangini - I, W/no- 28, PS- Siliguri, Dist- Darjeeling and she admitted that she sell the same to her design customers since long for her wrongful gain. On demand she failed to produce any valid documents or licence in r/o said liquor, accordingly I seized the same viz 1. Seven (07) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml (Total market value RS/- 120 X 07 = Rs 820/-) from the possession of Kusma Sahani(65yrs) W/o- Lt. Ram Vilas Sahani of Tikiapara, Matangini - I, W/no- 28, PS- Siliguri, Dist- Darjeeling (seizure and labelled was made between 15:20 hrs to 15.55 hrs) in presence of witnesses duly sign by the accused as well as witnesses. As she violated the rules and norms of Bengal Excise Act, as such I arrested her with the help of LC/1282 Swastika Sharma u/s 41 Cr.P.C appraise her ground of arrest and issued arrest memo in presence of witnesses.

I therefore pray before your kind honour to take legal action against the arrested Kusma Sahani(65yrs) W/o- Lt. Ram Vilas Sahani of Tikiapara, Matangini - I, W/no- 28, PS- Siliguri, Dist- Darjeeling under proper section of law.
