Respected Sir,

In producing herewith one accused person namely Smt. Malti Gajmir (F/43), W/O Lt Bhusan Gajmir of, Durga Nagar near Kali Mandir, w/n-40, PS-Bhaktinagar, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:-

1. Three (03) Shield Bottle 'KINGFISHER' Strong Beer of 650 ML each @ Rs/- 120/-
2. Four (04) Bottles Officers Choice liquor of 180 ML each @ Rs/- 130/-
3. Ten (10) Bottles Country Spirit styled as 60 UP PET "H!MALAYAN GOLD" of 600 ml each, @ Rs. 120/-
4. 01(One) Nylon Bag which used for carrying the seized articles SL. No. 1 to 3

I, ASI Biswajit Saha of Panitanki TOP under Siliguri PS/SPC herby lodge a written complaint against the above noted accused person to the effect that today i.e. on 03.07.2022 in course of Special Raid duty I received one secret source information to the effect that one lady person is carrying huge quantity of liquor illegally and through Sevoke Road M-Bazar towards Pronami Mandir Road under Siliguri PS/SPC. Accordingly the information shared to O/C, Panitanki TOP and thereafter as per his direction I along with, ASI Surojit Mallick, Const.-984 Subhasish Das, Const.233 Nagen Chandra Barman and LCV-1023 Basanti Singha arrived at Sevoke Road in front of Dominoz Pizza, Siliguri at 15.45 hrs being pointed out by the source, found that one lady person is proceeding with huge quantity of liquor containing with a Nylon bag. I intercepted the said accused person with loaded articles in presence of available witness namely Bijoy Chandra Jha (45), s/o Sri Hare Krishna Jha of Durga Nagar, w/n-40, PS-Bhaktinagar, Dist- Jalpaiguri. During interrogation the accused person failed to produce any documents/license in support of the same and stated that she sale the same to the local public at Durganagar under Bhaktinagar PS adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I seized the above noted articles under proper seizure list and labelled the same in presence of witnesses and duly sign by them and also by the accused person. The seizure was made between 15.55 hrs to 16.55 hrs on 03.07.2022. Then I arrested the accused person with the help LCV 1023 Basanti Singha, u/s 41 Cr.P.C. after explaining charge against her. The local public was also annoyed with her because of her this kind of illegal activities. As such there was no scope to serve Notice u/s 41A of Cr.P.C.

Hence, under the above noted circumstances I am submitting this written complaint against the above accused person namely Smt. Malti Gajmir (F/43), W/O Lt Bhusan Gajmir of, Durga Nagar near Kali Mandir, w/n-40, PS-Bhaktinagar, Dist- Jalpaiguri for starting a specific case under proper section of Law and to arrange for its investigation.
