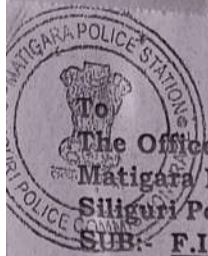

Sir,

In producing herewith one female accused person named Lalmai Begam (32 yrs) W/O Md Dulal of Biswas Colony, Sutki Godwn, PS- Matigara, Dist.- Darjeeling along with total 65.8 liters of illicit liquor under proper seizure list as mentioned below. The ground of arrest was duly been communicated with her.

(i) 30 (Thirty) bottles of 'Himalayan Gold 60 UP' Country Spirit containing 600 ml in each bottle i.e. total (30 x 600 ml) = 18.00 liters and value of Rs 120/- of each bottle total value (30 x 120/-) = Rs 3600/- and marked as "Exhibit- "A" out of which 01 (One) bottle taken as sample for examination and marked as "Exhibit A-1".

(ii) 26 (Twenty six) bottles of KINGFISHER STRONG PREMIUM BEER containing 650 ml in each bottle i.e total (26 x 650 ml) = 16.900 liters and value of Rs 120/- of each bottle total value (26 x 120/-) = Rs 3,120/- and marked as "Exhibit- "B" out of which 01 (One) bottle taken as sample for examination and marked as "Exhibit B-1".

(iii) 05 (Five) numbers of paper made pouch of Officer Choice Deluxe whisky containing 180 ml in each pouch i.e. total ( 05 x 180 ml) = 900 ml and value of Rs 130/- in each pouch total value ( 05 x Rs 130/- ) = Rs 650/- and marked as "Exhibit -C" out of which 01 (One) pouch taken as sample for examination and marked as "Exhibit C-1".

(iv) 01(one) big plastic container containing 30 (thirty) liters of local made Chullu and marked as "Exhibit-D" out of which 500 ml of Chullu taken in a plastic bottle as sample for examination and marked as "Exhibit-D-1".

I, PSI Sekhar Adhikary of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested female accused person namely Lalmai Begam (32 yrs) W/O Md Dulal of Biswas Colony, Sutki Godwn, PS- Matigara, Dist.- Darjeeling to the effect that on 04.07.2022 at 14.25 hrs received a source information that one lady namely Lalmai Begam W/O Md Dulal of Biswas Colony, Sutki Godwn is selling liquor at her residence since long without any valid documents. Accordingly, the fact was diarized in General Diary vide Matigara PS GDE No 208 Dated 04.07.2022 and shared the information with O/C Matigara PS and as per his kind order and direction myself along with force and LC/1251 Yankila Bhutia, LC/1286 Anisha Chhetri, LHG/01100028 Uma Roy all of Matigara PS left for Biswas Colony near Sutki Godwn to verify the veracity of the information in hand. On reaching there and as identified by the source we held raid at the residence of accused Lalmai Begam W/O Md Dulal of Biswas Colony, Sutki Godwn, PS- Matigara, Dist.- Darjeeling and managed to apprehended her by lady police personnel. On being asked she disclosed her identity as noted above and also disclosed that she is selling illicit liquor in her residence for her wrongful gain. Further being searched the above noted seized articles were recovered from the residence of the above noted accused named Lalmai Begam. On demand she failed to produce any valid license/papers for selling and storing of such articles. On further interrogation in presence of available witness and lady force she stated that she is involved in selling and possessing of liquor without any valid license for last few months for her illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above mentioned accused person named Lalmai Begam (32 yrs) W/O Md Dulal of Biswas Colony, Sutki Godwn, PS- Matigara, Dist.- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 04.07.22 in between 15.25 hrs to 16.45 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against arrested accused namely Lalmai Begam (32 yrs) W/O Md Dulal of Biswas Colony, Sutki Godwn, PS- Matigara, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
