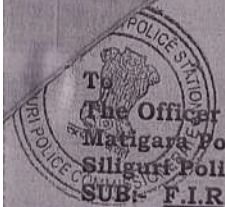

Sir,

In producing herewith one accused person named Rajkumar Biswakarma (52 yrs) S/O late Prithilal Biswakarma of Mahamaya Colony, Road No -9, PS- Matigara, Dist- Darjeeling along with following articles under proper seizure list. The ground of arrest duly been communicated with him.

(i) 13 (Thirteen) bottles of 'Himalayan Gold 60 UP' Country Spirit containing 600 MI in each bottle and value of Rs 120/- of each bottle and marked as "Exhibit- "A" out of which 01 (One) bottle taken as sample for examination and marked as "Exhibit A-1".

I, SI Goutam Mallik of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person namely Rajkumar Biswakarma (52 yrs) S/O late Prithilal Biswakarma of Mahamaya Colony, Road No -9, PS- Matigara, Dist- Darjeeling to the effect that on 04.07.2022 at 22.25 hrs received a source information that one person named Rajkumar Biswakarma of Mahamaya Colony, Road No -9, PS- Matigara, Dist- Darjeeling is selling liquor at his residence without any valid license. Accordingly the fact was diarized in General Diary vide Matigara PS GDE No 226 Dated 04.07.2022 and shared the information with O/C Matigara PS and as per his kind order and direction myself along with force had been to the house of the above noted accused to verify the veracity of the information in hand. On reaching there and as identified by the source we held raid at the house of accused Rajkumar Biswakarma of Mahamaya Colony, Road No -9, PS- Matigara, Dist- Darjeeling and managed to apprehended him. On being asked he disclosed his identity as noted above and disclosed that he is selling illicit liquor at his residence without any license for his wrongful gain. Further being searched the above noted seized articles were recovered from the house of the said accused. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above mentioned person named Rajkumar Biswakarma (52 yrs) S/O late Prithilal Biswakarma of Mahamaya Colony, Road No -9, PS- Matigara, Dist- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 04.07.22 in between 23.05 hrs to 23.45 hrs.




