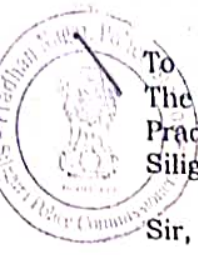

Sir,

In producing herewith one (01) arrested accused person namely Kalpana Roy (36) w/o Dulal Roy of Kalkut Road, beside Himcoah Bhawan, PO Champosari, PS Pradhan Nagar, Dist-Darjeeling along with the following articles under proper seizure as per seizure list;

a) One striped colour nylon bag containing 08 (Eight) bottles of Chlorpheniramine Maleate & Codeine Phosphate "ONREEX" Cough Syrup (each bottle containing 100 ml) having Batch No.070522-SD28, Mfg. Date: 05/2022. Exp. Date: 04/2024 which was kept inside one nylon bag - seized from the possession of above noted Kalpana Roy and marked as "Exhibit- A".

b) One (01) bottle of Chlorpheniramine Maleate & Codeine Phosphate "ONREEX" Cough Syrup (containing 100 ml) randomly taken from "Exhibit- A" for examination and marked as "Exhibit A-1".

I, SI Shibdhan Karmakar of Pradhan Nagar Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted accused person namely Kalpana Roy (36) w/o Dulal Roy of Kalkut Road, beside Himcoah Bhawan, PO Champosari, PS Pradhan Nagar, Dist-Darjeeling to the effect that on 02.07.2022 at about 14.25 hrs I received a specific source input that one lady possessing 'Codeine Phosphate' based drugs has kept such articles in her residence at Kalkut Road, beside Himcoach Bhawan, Devi Danga, P.O Champosari, PS Pradhan Nagar, Dist Darjeeling to sale the same to her designed local customers. The matter was diarized in Pradhan PS GDE No.101 Dt. 02.07.2022 and subsequently, I informed the matter to the Inspector-in-Charge, Pradhan Nagar Police Station in written and being directed, myself along with ASI Ashit Singh, ASI Tarun Kanti Ghosh, C/762 Majibul Rahaman, LC/1586 Uma Roy, CV/646 Baban Das, CV/645 Pankaj Gupta, CV/992 Jagadish Biswas, along with investigation kit left for Kalkut Road, beside Himcoach Bhawan under Pradhan Nagar PS by Govt. vehicle to verify the veracity of the information. This refers to Pradhan Nagar PS GDE No. 102 Dt. 02.07.2022 and M.C.C No-1603/2022 Date- 02. 07. 2022.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On way to Kalkut Road, beside Himcoach Bhawan under Pradhan Nagar PS I contacted two persons namely (1) Kamal Barman (45) S/O Lt. Bhupen Barman of Jalpai More, Sital Para, PS NJP, Dist Jalpaiguri, and (2) Mohan Mahato (38) S/O Lt. Ram Singh Mahato, Saman Nagar, PS Pradhan Nagar, Dist Darjeeling and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter, we along with above noted independent witnesses arrived at her residence at Kalkut Road, beside Himcoach Bhawan under PS- Pradhan Nagar at 15.15 hrs and subsequently, being pointed by my source detained one person who was found at her residence. She had kept one striped color nylon bag at her residence. Thereafter, we disclosed our identity and the information in hand and stated her that she as well as the bag under her possession will be searched for the purpose. And, I gave her option in writing to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which she agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused person to search our Police Party as per provisions but, she did not search the police party. Consequently, I informed the matter to I/C Pradhan Nagar PS and as per her kind order, I informed to Shri Maksudur Rahaman, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused person suspected to be possessed 'Codeine Phosphate' based drugs illegally and requested him to come at Kalkut Road, beside Himcoach Bhawan under PS- Pradhan Nagar to remain present and to supervise the search and seizure.

Accordingly at 15.55 hrs Shri Maksudur Rahaman, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC arrived at the spot at Kalkut Road, beside Himcoach Bhawan under PS- Pradhan Nagar as Special Executive Magistrate, SPC and in presence of two independent witnesses I searched the detained person with the help of Lady Constable and following all formalities, keeping her decency and recovered the above noted articles from the exclusive and conscious possession of the accused person namely Kalpana Roy (36) w/o Dulal Roy of Kalkut Road, beside Himcoah Bhawan, PO Champosari, PS Pradhan Nagar, Dist-Darjeeling.

It has been found from the bag under the possession of the above noted accused person namely Kalpana Roy containing 08 (Eight) bottles of "ONEREEX" cough syrup (each bottle containing 100 ml) containing 08 X 100 ml = 800 ml i.e., equivalent to 0.8 Kg].

Further, on demand in presence of Shri Maksedur Rahaman, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC the detained person namely Kalpana Roy failed to produce any valid documents/papers or explanation for possessing of such a huge quantity of 'Codeine Phosphate' based drugs beyond the prescribed limit.

Thereafter, I seized the recovered 08 (Eight) bottles [containing 800 ml i.e., equivalent to 0.8 Kg] of "PHENSEDYL" Cough Syrup [including 01 (one) bottle of "ONEREEX" Cough Syrup (containing 100 ml) which was taken randomly from the mother packet for examination] from the conscious possession of above noted accused person namely Kalpana Roy at the residence of her at Kalkut Road, beside Himcoach Bhawan under PS- Pradhan Nagar under proper seizure list in presence of independent witnesses and of Shri Maksedur Rahaman, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, SPC obtaining their signature and being acknowledged by the accused person.

Subsequently, I labelled and sealed the seized articles in presence of Shri Maksedur Rahaman, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, SPC and independent witnesses and the accused person namely Kalpana Roy. The whole process of seizure was made in between 16.10 hrs to 16.35 hrs.

Being further asked, the apprehend person namely Kalpana Roy admitted in presence of Shri Maksedur Rahaman, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC and other independent witnesses that she have procured the 'Codeine Phosphate' based drugs clandestinely for the purpose of selling the same in high rate to his designed local customer for her personal gain by illegal means. She also disclosed that she have been dealing in this business of procuring and selling of 'Codeine Phosphate' based drugs illegally for last few months for his wrongful gain.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused person namely Kalpana Roy are involved in procuring and selling 'Codeine Phosphate' based drugs illegally contravening the norms of NDPS Act.

Then, I arrested the above noted accused person namely Kalpana Roy after observing all formalities and informing the ground of his arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person Kalpana Roy (36) w/o Dulal Roy of Kalkut Road, beside Himcoah Bhawan, PO Champosari, PS Pradhan Nagar, Dist-Darjeeling and arrange for its investigation.
