Subject: Written Complaint

Respected Sir,

I SUBHADIP SAHA, S/o Late Nikhil Saha, resident of Maharaj Colony, Ward No. 4, Behind Vishal Mega Mart, Bardwan Road, Siliguri would like to bring to your kind notice that yesterday at around 9:30 pm I went to visit my friend's house at Baghajatin Colony Main Road, Beside Kanchanjunga Club, Pradhan Nagar, Siliguri on my scooter (details of which are described below) for attending an invitation. After I reached my aforesaid friend's house I parked my aforesaid scooter in front of the entrance gate of my aforesaid friend's house and I went inside. After that at around 10:00 pm when I came outside my friend's house I found out that my aforesaid scooter is missing from the place where it was supposed i.e. in front of my aforesaid friend's house, thereafter I searched for my scooter, also enquired the neighbours if they have seen my scooter but in vain. Please take a note during my search in the neighbourhood I got to know that some unknown person was sitting on my scooter where it was parked and he was sitting there constantly for around 15-20 minutes and then he took the scooter with him. Please take a note that presently I am working in a sector where my aforesaid scooter is the most necessary thing for earning my daily livelihood and if the aforesaid unknown person who has committed an act of stealing somehow manages to misappropriate and/or dispose off the same I will suffer and irreparable amount of loss and damage.

Moreover, please also take a note of that inside the compartment of my scooter beneath my seat all the original documents with respect to the aforesaid vehicle along with the extra key which was there inside the bag was also stolen by the said unknown person along with the scooter.

Therefore request you to kindly look into the matter and do the needful accordingly in this regard before the said unknown person dispose off my said scooter and oblige.
