With due respect and humble submission, in producing herewith one accused namely Pankaj Singh (25) S/o Ramasish Singh of Gurung Busty, Ramnarayan Math, P.S-Pradhannagar, Dist. Darjeeling under arrest along with following articles under proper seizure ;

**i) 20(Twenty) Plastic bottles of 70 UP , Country Spirit, KACHI each bottle containing 300 ML, Biended & Bottled by Prakash Disitery & Chemical Co (P) Ltd, Bandri  
Jote, Pradhannagar, Siliguri**

I ASI Tarun Kanti Ghosh of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today i.e on 03.07.22 myself along with force CV/645 Pankaj Gupta, CV/128 Ajay Kr Sahani all of Pradhannagar PS left for evening Patrolling duty at PS area, Vide Pradhannagar PS GDE No.180 dtd.03.07.22 and during patrolling duty at 18.15hrs, I received a source information that one person named Pankaj Singh was storing and selling liquor illegally in his petty shop at Siliguri Junction under Pradhannagar PS. Accordingly I share the information with you, and as per your direction rush to the spot and as pointed by the source we apprehended the above noted person and on search his shop, recovered above noted articles, On demand he failed to produce any valid document in respect of recovered articles. On interrogation he admitted that he is selling the same illegally without obtaining valid document for her illegal gain. Accordingly, I seized & label the above noted articles in between 18.45 hrs to 19.15 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Pankaj Singh (25) S/o Ramasish Singh of Gurung Busty, Ramnarayan Math, P.S-Pradhannagar, Dist. Darjeeling and arrange for its investigation.
