It has been reported by our technical staffs and local authority that the transformer cutout of 100KVA transformer located at the below mentioned address has been found missing on 02.07.2022 which causes power interruption in the consumers in that locality. After such information the site was thoroughly examined and found that the cutout of the transformer has been taken out by external means. This inconvenience has created a severe power outage and havoc consumer grievance in that location which was faced by office of the undersigned. Details given below:
