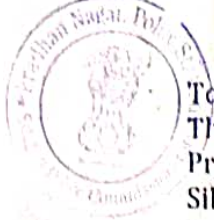

Sir,

In producing herewith one accused person named Arjun Rai (54) S/O- Late Nathuni Rai of Mallaguri near Over Bridge P.S- Pradhannagar Dist- Darjeeling along with the following seized articles :-

1. 09 (nine) bottles of Himalayan Gold 60 up country spirit containing 600 ml. each manufactured by Himalayan Endeavour PVT. Ltd. Siliguri , West Bengal.

I, ASI Nilam Sarnakar of Pradhannagar P.S. under Siliguri Police Commissionerate do here by lodged a written complaint against Arjun Rai (54) S/O- Late Nathuni Rai of Mallaguri near Over Bridge P.S- Pradhannagar Dist- Darjeeling to the that today on 04/07/2022 while I was performing Special raid duty as per order of my superior vide Pradhannagar P.S. GDE NO-244 date 04/07/19, received a specific input from the source at 18:55 hrs. that the above noted person has kept huge numbers of illicit liquor in his Hotel name and style as "Raj Hotel" at Mallaguri near Over Bridge in order to clandestinely dispose the same. Accordingly the fact is informed to I/C Pradhannagar PS and as per his direction I along with CV-645 Pankaj Gupta and CV-223 Swapan Chettri left for Mallaguri under Pradhannagar PS to verify the veracity of the information. On reaching there and as identified by source cordoned the shop where he kept illegal alcohol.. On arriving there found the above noted person who disclosed his identity as noted above who kept the same at his shop in conceal position. On search found 09 bottles of Himalayan Gold country made spirit containing 600 ml. each of illegal liquor .On being interrogation he could not produce any valid documents in respect of the said illicit liquor.. He also stated that he is doing this liquor business since last 04 months for wrongful gain. Accordingly I seized the same in presence of witness as per proper seizer list duly signed by the witnesses. The seizure was made in between 19:40 hrs 20:05 hrs . On being asked he stated that he kept the same with a view to sale and supply at Mallaguri area without any valid documents. As he has violated the norms of Bengal Excise Act as such I arrested him after observing all sorts rules for selling the said country made spirit and beer without valid license.

Therefore I pray before your honour that a specific case may kindly be started against accd. Arjun Rai (54) S/O- Late Nathuni Rai of Mallaguri near Over Bridge P.S- Pradhannagar Dist- Darjeeling as per proper section of law.
