In producing here with the one arrested accused person namely (1) Arpan Rai(35) S/O- Ratan Rai of Teesta Bridge, PS- Kalimpong, Dist- Kalimpong A/P- Boro Fapri, P.S - Bhaktinagar, Dist-Jalpaiguri along with the following seized articles as per proper seizure list:

1) 06 (Six) bottles of "Himalaya Gold" 60 UP country spirit each bottle containing 600 ML.

2) 09 (Nine) bottles of Tuborg Strong premium Beer each bottle containing 650 ML.

3) '03 (Three) bottles of EM Boss fine whisky each bottle containing 750 ML.

I, SI Rantu Halder of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person to the effect that on 04.07 2022 while performing special raid duty under Bhaktinagar PS area vide BKN PS GDE No.167 Dated. 04.07.2022 at about 17.45 Hrs I received source information that the above noted accused person have possessed huge amount of Liquor in his hotel at Salugara Bazar, under Bhakti Nagar PS for the purpose of selling the same to local customers. Accordingly the information shared before you and as per your kind direction I along with Constable C/1431 Dilip Barman, CVF-614 Sumit kr Roy CVF/ 619 Dharmendra Roy headed towards Salugara Bazar, to verify the veracity of the information. At about 18.25 hrs we reached at Salugara Bazar and as shown and being identified by the source held raid and apprehended one person who disclosed their identity as noted above. Further maintaining his decency and observing all formalities searched him and recovered huge amount of above noted seized liquor from his possession. On demand he could not produce any valid documents/licence in respect of the recovered liquor. On enquiry the apprehended person admitted his guilt and confessed that he have possessed above noted liquor at his shop for the purpose of selling to his designed customers. He also stated that he have been doing this illegally since long without any valid licence or Documents for their wrongful gain. Accordingly, I prepared seizure list of the above noted articles in presence of witnesses duly sign by the accused as well as witnesses. The seizure made between 18.55 Hrs to 19.45 Hrs. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your kind honour that a specific case may kindly be registered against the accused person namely (1)) Arpan Rai(35) S/O- Ratan Rai of Teesta Bridge, PS- Kalimpong, Dist-Kalimpong A/P-Boro Fapri, P.S - Bhaktinagar, Dist-Jalpaiguri under proper section of law and arrange for its investigation.
