Respected Sir/Madam

This is to inform you that I, Smt. Pranka pal sarkar, Wife of Nityananda pal and daughter of late Jitendra Chandra sarkar, Resident of Sukantanagar pran Krishna sarani by lane, P.O Rabindra sarani , P.S Bhaktinagar ,Dist –jalpaiguri -06. That my father and uncle namely Madhusudhan Sarkar (BOTH ARE SONS OF LATE MAHESH CHANDRA SARKAR) had jointly purchased of land measuring 2.66 decimal vide deed no 2229 dated 25.03.1968, 3830 dated 07.05.1968 and deed no. 7046 dated 13.07.1968 and the said deeds was registered according to as per law .Thereafter my father and uncle was enjoying peaceful possession of the said land .

That it is stated, that my father and uncle had jointly sold out of the land measuring 1.91 decimal in the year 1975 dated 30.01.1975 vide deed no. 753 after selling the above mentioned land both are enjoying 0.75 decimal land (2.66 decimal-1.91 decimal=0.75 decimal)

That my father had died on 12.03.1995 at E. vivekannanda pally, siliguri and leaving me and other legal heirs , my brother namely Dilip sarkar and 2 sisters according to Hindu succession act , 1956. That my above named uncle is still alive .

That it is submitted that I came to know from a reliable source that my uncle's son namely Sri Pradip sarkar and two other unknown persons above named opposite parties NO.2&3 executed a general power of attorney in favour of Sr. Kumaresh sarkar . In fact said Babul sarkar son of late Anil sarkar and Durga mandal daughter of late Anil sarkar are not the legal heirs of Late Jitendra Chandra sarkar .

That there after I searched and collected the said General Power of Attorney from the concerned office and after going through the content of said General Power of Attorney it is found that the said General Power of Attorney was registered at private residence of Sri Pradip sarkar on 27.09.2018 which is bad in law and void.

That it is crystal clear that above named opposite parties made out a false and concocted story for the purpose of execution of said Power of attorney and signed a deed of conveyance or any instrument in respect of undivided vacant land of measuring 0.2215 acres being R.S. plot no. 385/748 and 385 corresponding to L.R plot No. 50 and R.S. sheet No.9 and L.R. sheet No . 58, R.S.khatain No. 459/17 and L.R. Khatain No .212, P.S. Bhaktinagar , Dist . Jalpaiguri-

That it is also submitted said O.P. No. 4 had already executed a deed of conveyance in the strength of said false and fabricated Power of Attorney in favour of Era Construction Pvt. Ltd., represented by one of his director namely Sandeep Agarwal, son of Chhabil Dass Agarwal, residing at 2.5 Mile Sevoke Road, Siliguri, P.O. Sevoke Road, Dist. - Jalpaiguri, 734001 vide deed no. 5914/2018 which was registered before the A.D.S.R. Bhaktinagar.

That the above fact and circumstances it is crystal clear that the abovesaid O.Ps have jointly made a conspiracy against me and made a false and concocted story to sell out my share of land with the help of O.P. 6 namely Tarashi Xanti Ghosh and cheated me and made a forged and fabricated documents and also made a misrepresentation of the legal heirs of late Jitendra Chandra Sarkar and committed the offence under Indian Penal Code.

So I request you to take legal action against the all above named Opposite Parties as per I.P.C. and law of the land.
