L.R. Plot No. 928, J.L.No. 03, Sheet No. 11, situated within Mouza-Binnaguri,
P.O. Sahudangi Hat, Police Station-New Jalpaiguri, District -Jalpaiguri.

That I purchased the above mentioned land through Registered sale
deed, being sale deed No. 2938 dated 16.03.2022 executed by the then owner
Srimati Sefali Mandal wife of Narayan Mandal of village- village-Jamurivita, P.O.
Sahudangi Hat, P.S. New Jalpaiguri, District-Jalpaiguri in favour of me which was
duly registered before A.D.S.R. Bhaktinagar, District- Jalpaiguri as fully
described in the schedule hereunder.

That after purchasing the said land measuring 02Kathas 08 Chhatak fully
mentioned in Schedule below I took possession over the said land and constructed
three Tin shed Houses in a portion of the said land and I have been enjoying
the same without obstruction from any corner.

District-Jalpaiguri by making criminal conspiracy with some antisocial persons of
our locality is threatening me to grab my land with houses.
