Kurseong Bishnu Pt. Sharma, was travelling with my  
son Pratik Sharma in our Private car WB 26T 1455.  
We were on our way to our home i.e,  
Deridanga, as we crossed darjeeling more one  
Red Tata Sumo with number plate bearing no.  
WB 73 D 1090 hit us intentionally just because  
he was not given space to pass as there  
was no space, and he fled away. Moreover, that  
driver seemed drugged. Therefore my two kids, one aged  
seven years and other 3 years was also on our  
car and we write you this as this accident  
could have been more worse.
