Sir,

I, ASI Dipak Karmakar of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against owner of Louis Restaurant to the effect that on 04.07.2022 while performing special raid duty under Bhaktinagar PS area vide BKN PS GDE No. 167 Dated 04.07.2022 at about 19.45 Hrs I received source information that the above noted hotel have possessed huge amount of Liquor at Raj Fapri, under Bhakti Nagar PS for the purpose of selling the same to local customers. Accordingly the information shared before you and as per your kind direction I along with Constable C/986 Rajib Sarkar, CVF-935 Biplab Roy CVF/ 614 Sumit Kumar Roy headed towards Raj Fapri to verify the veracity of the information. At about 20.35 hrs we reached at Raj Fapri and as shown and being identified by the source held raid at the above noted hotel but the owner of the said hotel flew away from the spot after seeing police team after that we searched the hotel and recovered huge amount of seized liquor from his possession.

- 1) 15 (Fifteen) bottles of Old Monk Deluxe Rum each bottle containing 750 ML
- 2) 02 (Two) bottles of Mc'Dowells No-1 whisky each bottle containing 750 ML
- 3) 12 (twelve) bottles of Tuborg Strong premium Beer each bottle containing 650 ML.

He have possessed above noted liquor at his shop for the purpose of selling to his designed customers. We came to know that he have been doing this illegally since long without any valid licence or Documents for his wrongful gain. Accordingly, I prepared seizure list of the above noted articles in presence of witnesses duly sign by the witnesses. The seizure made between 20.35 Hrs to 21.15 Hrs..

I, therefore pray before your kind honour that a specific case may kindly be registered against the owner of the Louis Restaurant Raj Fapri under Bhaktinagar PS under proper section of law and arrange for its investigation.
