

8.that on 27//03/22 at 1 am Bharat Roy, and her husband tried to kill her by pressing pillow on her face and tried to kill her by suffocation.

9.that over this incident the complainant lodged a written complain at matigara police station on 6/4/22 but the matigara police did not start any specific case against the accused persons.(enclosure B).

10.that knowing the fact that the accused persons are high link police did not start any specific case, the compliant lodged a written complain before the commissioner of police but the commissioner of police did not take any step(enclosure C).

accused persons, may be in furtherance of their common intention and the averments of the complaint clearly makes out offence of cruelty and attempt to murder which are cognizable offences and police authorities were required to register the FIR against the accused persons under the relevant section on the complaint lodged by the complainant but due to the high links, money power and influence of the accused, the police did not take action against the accused person and only entered the complaint in the 'public complaints greaters' which a Declar maintained in the police station.
