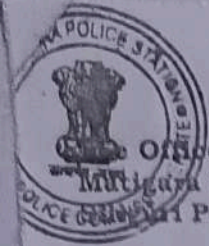

Sir,

In producing herewith one accused person named Anwar Ali (35 yrs) S/O Late Md Kalamuddin of Matigara fish Market, PS- Matigara, Dist- Darjeeling along with following articles under proper seizure list. The ground of arrest duly been communicated with him.

(i) One nylon bag containing 14 ( Fourteen) bottles of 'Himalayan Gold 60 UP' Country Spirit, each bottle containing 600 Ml and value of Rs 120/- of each bottle and marked as "Exhibit- "A" out of which 01 (One) bottle taken as sample for examination and marked as "Exhibit A-1".

I, SI Goutam Mallik of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person namely Anwar Ali (35 yrs) S/O late Md Kalamuddin of Matigara fish Market, PS- Matigara, Dist- Darjeeling to the effect that on 06.07.2022 at 20.05 hrs I received a specific source information that one person named Anwar Ali of Matigara fish Market, PS- Matigara, Dist- Darjeeling is selling liquor at Paribahan Nagar under PS- Matigara, Dist- Darjeeling without any valid license. Accordingly the fact was diarized in General Diary vide Matigara PS GDE No 324 Dated 06.07.2022 and shared the information with O/C Matigara PS and as per his kind order and direction myself along with force had been to Paribahan Nagar to verify the veracity of the information in hand. On reaching there and as identified by the source we held raid at Paribahan Nagar and managed to apprehended him with a nylon bag containing illicit liquor in his right hand. On being asked he disclosed his identity as noted above and disclosed that he is selling illicit liquor at Paribahan Nagar without any license for his wrongful gain. Further being searched the above noted seized articles were recovered from his possession. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above mentioned person named Anwar Ali (35 yrs) S/O late Md Kalamuddin of Matigara fish Market, PS- Matigara, Dist- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 06.07.22 in between 21.05 hrs to 21.45 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against the arrested accused namely Anwar Ali (35 yrs) S/O late Md Kalamuddin of Matigara fish Market, PS- Matigara, Dist- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
