Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 34 dated 01.07.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP/13 Jamirul Islam, CV/306 Biswajit Roy and CV/824 Niru Yadav all of NJP PS, SPC left for Hirapur, Nichpara PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 1935 hrs we arrived at Haripur, Nichpara and being identified by the source I held raid at the shop of the said accused and managed to apprehended him. During interroghation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted 1/D liquor recovered from his shop. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop.
