With due respect, I am producing herewith one arrested accused person namely Babun Mahato (45) s/o Naren Mahato of Sasan para, Hatidanga, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been co

municated with him

1. 17 (Seventeen) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml, Total 15.300 liters).
2. 03 (three) bottle of McDowell's Rum (each containg 180 ml, total 540 ml)
3. 03 (Three) Bottle of Kingfisher Strong Premium Beer containing 650 MI in each Botle.

I, PSI-Newton Biswas presently attached with NJP PS under your kind control beg to state that today i.e. on 01.07.2022 at 1915 hrs I received a secret source information that one person namely Babun Mahato (45) s/o Naren Mahato of Sasan para, Hatidanga, PS- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his shop at NJP Hotel Line, under New Jalpaiguri PS, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 34 dated 01.07.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP/13 Jamirul Islam, CV/306 Biswajit Roy and CV/824 Niru Yadav all of NJP PS, SPC left for Hirapur, Nichpara PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 1935 hrs we arrived at Haripur, Nichpara and being identified by the source I held raid at the shop of the said accused and managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his shop. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 1955 hrs to 2025 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Babun Mahato (45) s/o Naren Mahato of Sasan para, Hatidanga, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
