Sir,

With due respect, I am producing herewith one arrested accused person namely Raju Ghosh s/o Lt. Biren Ghosh of Ambikanagar, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 04 (Four) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml.)
2. 04 (seven) bottles of MAHARAJA Rare Whisky (containing 750 ml in each bottle)
3. 02 (two) bottle of McDowell's Rum (each containing 180 ml, total 360 ml)
4. 02 (two) bottle of EMBOSS fine whisky (each containing 375 ml)

I, ASI-Sajal Das presently attached with NJP PS under your kind control beg to state that today i.e. on 05.07.2022 at 06.45 hrs I received a secret source information that one person namely Raju Ghosh s/o Lt. Biren Ghosh of Ambikanagar, PS- NJP, Dist.- Jalpaiguri is selling I/D liquor illegally at his house at Ambika nagar, PS- NJP, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 209 dated 05.07.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP/08 Laxman Roy, HG/794 Ranjit Roy all of NJP PS, SPC left for Ambikanagar, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 07.35 hrs we arrived at Ambikanagar, and being identified by the source I held raid at the shop of the said accused and managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling I/D liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his house. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his house. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 07.35 hrs to 08.05 hrs

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Raju Ghosh s/o Lt. Biren Ghosh of Ambikanagar, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
