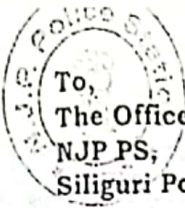

Sir,

With due respect, I am producing herewith one arrested accused person namely Dilip Roy s/o Lt. Ropa Roy of South Colony, Puchkolguri, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

- 3. 07 (seven) bottles of MAHARAJA Rare Whisky (containg 750 ml in each bottle)
- 4. 05 (five) bottle of Officer Choice Deluxe Whisky (containg 180 ml in each bottle)

I, PSI-Newton Biswas presently attached with NJP PS under your kind control beg to state that today i.e. on 05.07.2022 at 06.45 hrs I received a secret source information that one person namely Dilip Roy s/o Lt. Ropa Roy of South Colony, Puchkolguri, PS- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his house at South Colony, PS- NJP, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 209 dated 05.07.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP/08 Laxman Roy, HG/794 Ranjit Roy all of NJP PS, SPC left for South Colony, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 07.25 hrs we arrived at South Colony, and being identified by the source I held raid at the shop of the said accused and managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his house. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his house. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 07.25 hrs to 07.45 hrs

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Dilip Roy s/o Lt. Ropa Roy of South Colony, Puchkolguri, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
