
With due respect, I am producing herewith one arrested accused person namely Brojen Roy (38) S/O Digen Roy of Baribhasa, P.S- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 07 (seven) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml).
2. 03 (three) bottles of McDowell's No1 superior whisky (each containing 180 ml, total 540 ml)

I, ASI-Sujal Das presently attached with NJP PS under your kind control beg to state that today i.e. on 05.07.2022 at 22.10 hrs I received a secret source information that one person namely Brojen Roy (38) S/O Digen Roy of Baribhasa, P.S- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his house at Baribhasa, PS- NJP, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 255 dated 05.07.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP/08 Laxman Roy, HG/794 Ranjit Roy all of NJP PS, SPC left for Baribhasa, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 22.45 hrs we arrived at Baribhasa, and being identified by the source I held raid at the shop of the said accused and managed to apprehend him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his house. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his house. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 23.15hrs. to 23.50 hrs


