Sir,

With due respect, I am producing herewith one arrested accused person namely Anup Sarkar (55) S/O Lt. Raghunath Sarkar of Paglahat, P.S- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 05 (five) bottles of Kingfisher Strong Beer (each bottle containing 650 ml.).
2. 02 (two) bottles of McDowell's No1 superior whisky (each containing 180 ml. total 360 ml)
3. 02 (two) bottles of McDowell's No1 Rum (each containing 180 ml. total 360 ml)
4. 01 (one) bottle of Bull Fighter Whisky containing 750 ml.
5. 01 (one) bottle of officer choice whisky containing 750 ml.

I, PSI Newton Biswas presently attached with NJP PS under your kind control beg to state that today i.e. on 06.07.2022 at 08.15 hrs I received a secret source information that one person namely Anup Sarkar (55) S/O Lt. Raghunath Sarkar of Paglahat, P.S- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his hotel at Fulbari Bypass, PS- NJP, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 273 dated 06.07.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP/13 Jamirul Islam, Cv/306 Biswajit Roy all of NJP PS, SPC left for Fulbari Bypass, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 08.45 hrs we arrived at Fulbari Bypass, and being identified by the source I held raid at the shop of the said accused and managed to apprehend him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his shop. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his house. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 08.55 hrs. to 09.15 hrs

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Anup Sarkar (55) S/O Lt. Raghunath Sarkar of Paglahat, P.S- NJP, Dist.- Jalpaiguri and arrange for its investigation.
