


Sub: FIR

W.B., I would like to inform you that
today around 10:45 PM, I along with my
husband had gone to Four Vedas for
wedding reception. At that time Mr.
Ranjendra K. Jain, resident of S.F. Road,
Siliguri suddenly attack my husband
and assaulted him badly, in front of
main entrance. When I tried to save my
husband, he pushed me back and
abused me by my cast i.e. schedule
tribe within public view. Subsequently, he
threatened us with dire consequence.
