In producing herewith five (05) arrested accused persons namely (i) Md Ijaj Hussain @ Ajaj (24yrs) S/o- Md. Samir Hussain of Tikiapara, Matangini- II, Ward no- 28, PS-Siliguring, Dist- Darjeeling, (ii) Bikash Yadav (21yrs) S/o- Sobhid Yadav of Tikiapara, Matangini- II, Ward no- 28, PS-Siliguri, Dist- Darjeeling, (iii) Ajay Sahani (29yrs) of Sahid Colony, FCI gate, Ward no- 35, PS- NJP, Dist- Jalpaiguri, (iv) Rabi Gupta@ Tikiapara, Sahid Colony, PS-SatyaNarayan Prasad Gupta of Simultala, Balason, PS-Matigara, Dist-Darjeeling and (v) Sambhu Roy @ Chokfula (30yrs) S/o- LateSuren Roy of Siliguri Town station, PS-Siliguri arrested u/s- 41 Cr.P.C along with following seized articles viz:

- 1. One (01) iron made sword measuring 23 inch (approx) including wooden butt from the possession of Md Ijaj Hussain @ Ajaj which was kept concealed on his back side
- 2. One (01) iron made crowbar measuring 17 inch (approx) from the possession of Bikash Yadav which was kept on his right hand
- 3. One (01) iron made sabol measuring 18 inch (approx) from the possession of Ajay Sahani which was kept on his left hand
- 4. One (01) iron made sword measuring 30 inch (approx) including butt from the possession of) Rabi Gupta which was kept concealed on his back side
- 5. One (01) iron made 'Knife' measuring 08 inch (approx) from the possession of Sambhu Roy @ Chokfula which was kept concealed on his left pocket
- I, ASI Siben Sarkar S/O Raghupada Sarkar of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely i) Md Ijaj Hussain @ Ajaj, (ii) Bikash Yadav, (iii) Ajay Sahani (iv) Rabi Gupta and (v) Sambhu Roy and others to the effect that today on 07.07.2022 at 00.45 hrs received a sources information that 12/13 persons have assembled at the Bagrakote, Railway Track near Sabji Market under Siliguri PS with a view to commit dacoity at Bagrakote area. The fact was diarized in GD vide Siliguri PS GDE No- 393 dated 07.07.2022. Subsequently, after sharing the information with I/C Siliguri PS and as per his direction, I along with ASI- Rabin Lama, ASI Debasish Das, C/971 Sanjay Roy, CV/283 Prasenjit Dey, CV/622 Ramanath Barman left for the place to work out the information. At about 01.15 hrs after reaching near Bagrakote sabji bazar, I met my source and being pointed by the source we started walking towards Bagrakote, Railway Track near Sabji Market. After reaching Bagrakote, Railway near Sabji Market and started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from the spot seeing police personnel approaching towards them. They tried to flee away but on hot chase we managed to apprehend above noted five (05) accused persons along with seized articles as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Bagrakote area.

ASI Siben Sarkar Siliguri PS/Spc A. 07.07.22 I thereafter, seized the above noted weapons under proper seizure list duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 01.45 hrs to 02.35 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

l accordingly brought the arrested accused persons along with seized article at Siliguri Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house at Bagrakote area. It is also revealed from them that some others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (i) Md Ijaj Hussain @ Ajaj(24yrs) S/o-Md. Samir Hussain of Tikiapara, Matangini- II, Ward no- 28, PS- Siliguring, Dist-Darjeeling, (ii) Bikash Yadav (21yrs) S/o- Sobhid Yadav of Tikiapara, Matangini- II, Ward no- 28, PS- Siliguri, Dist- Darjeeling, (iii) Ajay Sahani (29yrs) of Sahid Colony, FCI gate, Ward no- 35, PS- NJP, Dist- Jalpaiguri, (iv) Rabi Gupta@ Tiki (19yrs) S/O-SatyaNarayan Prasad Gupta of Simultala, Balason, PS- Matigara, Dist- Darjeeling and (v) Sambhu Roy @ Chokfula(30yrs) S/o- Late Suren Roy of Siliguri Town station, PS-Siliguri and others and arrange for its investigation.
