Sir,

In producing here with the seized articles viz:-

- (i) 02(Two) nos. HP domestic Gas Cylinder each cylinder partially loaded.
- (ii) 02(Two)nos. Indane domestic Gas Cylinder each cylinder partially loaded.
- (iii) 01 (one) gas pipe length about 04 (four) fit with fitted one gas Regulator.

under proper seizure list. I SI Goutam Kundu of Enforcement Branch, Siliguri Police Commissionerate do hereby lodge a written complaint against the owner namely Nripen Saha (45yrs) owner of "New Biryani House" of Deshbandupara main Road, Opp- Deshbandu Medical Store, PS- Siliguri, Dist Darjeeling. Who was illegally procured the domestic Gas cylinder at his Briyani Stall styled as "New Biryani House" for commercial purpose without any valid documents or licence to the effect that today i.e. 07.07.22 at about 14:35 hrs received an information from reliable source that above noted Briyani Stall Styled as "New Biryani House" situated at above mentioned addressed using the domestic Gas cylinder at his Briyani Stall for using commercial purpose for wrongful gain.

Accordingly, the matter informed to ACP EB SPC and as per his direction I, along with, ASI Prashanta Bardhan, ASI Ashoke Biswas, C/924 Avijit Kar, all of EB SPC with investigation kit left for Siliguri PS vide EB SPC Special C.C No 38/22 Dt. 07.07.2022. The matter informed to Siliguri PS for providing police assistance vide Siliguri PS GDE No. 437 dated 07/07/22. At 14:45 hrs myself along with ASI Paresh Ch, Roy, C/1179 Mantu Debnath of van K-21 II (Siliguri PS) vide Siliguri PS MCC NO 969/22 Dated 07/07/2022 had been to Deshbandupara main Road, Opp- Deshbandu Medical Store, PS- Siliguri, Dist Darjeeling to work out the information and apprised them about the information in hand and requested them to accompany with us during search and seizure. As per source information we reached and entered into the Briyani Stall styled as "New Biryani House" situated at Deshbandupara main Road, Opp- Deshbandu Medical Store, PS- Siliguri, Dist Darjeeling. During search found worker of Briyani Stall by using the domestic HP and Indane Gas cylinder without any valid documents for commercial Purpose use, On demand they failed to produce any valid documents in support of using the HP and Indane domestic gas cylinders in the kitchen of said Briyani Stall for commercial purpose. Further local enquiry it revealed that the above noted Briyani Stall's owner is using the domestic gas cylinder for preparing Food Items at the Briyani Stall for commercial purpose in order to wrongful gain without any valid document. I also invited two independent witnesses namely (1)Swapan Majumder (52) S/O Sankar Majumder of Deshbandupara main Road, PS- Siliguri, Dist Darjeeling (2) C/924 Avijit Kar of Enforcement Branch Siliguri PC .

During local enquiry it could be learnt that the Briyani Stall owner namely Nripen Saha (45yrs) owner of "New Biryani House" of DeshbanduPara main Road, Opp- Deshbandu Medical Store, PS- Siliguri, Dist Darjeeling using the domestic gas cylinder abundantly for commercial purpose. Subsequently I seized the above noted articles from the possession of his staff namely Bishnu Das (32yrs) S/O Lt Bhakti Das, Ramnagar, PS_ Habibpur Dist -Malda, During further investigation Bishnu Das, staff of the stall unable to produce any supporting documents for using domestic gas cylinder at their stall for business purpose. Seized the articles from the possession of him after preparing proper seizure list and label in the presence of witnesses noted above. The seizure was made in between 15:45 hrs to 16:15 hrs. But found the owner of Briyani Stall Nripen Saha absconded from the shop to evade police arrest to seeing the police party..

Hence, I pray that specific case may kindly be started under section 285 IPC r/w 7(i)(a)(b)(c) of Essential Commodities Act 1955 against the accused person namely Nripen Saha owner of Briyani Stall Styled as "New Biryani House" situated at , Deshbandupara main Road, Opp- Deshbandu Medical Store, PS- Siliguri, Dist Darjeeling and arrange for its investigation.
