Dilip Keshari and her sons namely (2) Ganesh Keshari (3) Sachin Keshari (4) Ashish Keshari & (5) Smith Keshari all sons of late Dilip Keshari, all we of Shivaji Road (Tula Guli) Khalpara Sabji Mandi, Ward No-8 SMC P.O & P.S.-Siliguri, Distt-Dejalej, and started abusing me & my family members in filthy languages and when I told them to go away from here, then the said Smt. Shila Devi Keshari caught me from back and her above named sons namely (2) Ganesh Keshari (3) Sachin Keshari (4) Ashish Keshari & (5) Smith Keshari started beating me & my brother namely Abhay Keshari (25) with leather belt and iron chain, and they torn off my T. shirt and derobed me.
