would like to inform that Today on 08/7/12
at around 20.25 hrs to 20.30 hrs I myself along
my wife Suniti Sinha when returning from
Matabirsthan Sabji Bazar via Matabirsthan
Chowpatty. When we reaching at Matabirsthan
Chowpatty at that time one red color Toto
coming from New Cinema Hall road side with
excessive speed and dashed my wife. When I
asked the Toto driver to go slow, he did
not pay any heed and became more aggressive
also usage filthy language to my wife. When I
protest him at that he came forward
me and assaulted me on my forehead
with a sharp cut weapon like screw driver.
Resulting I receive sharp cut injury on my
forehead. At that time my wife tried
rescue me, but the Toto driver catch her
putting her churidar shirt and push her
and resulting outdressed her modesty. He
also told us showing the screw driver
that he will kill us. The local people
came forward to and rescue us. and approach
the Toto driver. Said Toto driver introduced
himself as Md Sarfaraj of Rajaholi, N.S.P. The
local people shifted me to Siliguri Hospital.
Accordingly, I examined by the attending M.O. of
Siliguri hospital.

Hence, I pray before you that legal steps
may kindly be taken against the Toto driver
Md Sarfaraj of Rajaholi as per law.
