Respected Sir,

I, Sri Suresh Bhagat, son of Sri Dudnath Bhagat, resident of Sishu Dangi, near Sishu Dangi Primary School, Post Office and Police Station Matigara, District Darjeeling, Pin- 734010, would like to lodge this complain as follows:

That Algo Bhagat, son of Late Sukcharan Bhagat, since deceased was my grandfather, purchased a piece or parcel of land measuring 1.33 Acre, recorded in Khatian No.05, Plot Nos. 306, 308, 309, 342, 303 and 343, within Mouza - Thumba, Pargana- Patharghata, Police Station Matigara, District Darjeeling by a deed of conveyance registered on 22.01.1962 at Sub-Registry Office, Siliguri and recorded in Book No., Being No. 285 for the year 1962.

That recently some unknown persons came to our property and demanded that they are the owners of the said property by way of purchase from Shankar Bhagat & Sambhu Bhagat, son of Late Raj Kishore Bhagat of Sishu Dangi Police Station Matigara, District Darjeeling. The above persons showed me some documents for the said property in their names. Seeing the above, I obtained certified copy of the Title Deed Being No. 285 for the year 1962 from District Sub-Registry Office, Darjeeling and it appears that the said Volume was tampered and the name of one Raj Kishore Bhogat, son of Shew Charan Bhagat is fraudulently incorporate as purchaser, erasing and tampering the name of Algo Bhagat as purchaser and some other portions of the recitals of the said volume are also tampered.

Sir, it is reasonably believe that without the collusion of the employee(s) of the District Sub-Registry Office it was impossible to tamper the official document i.e. the Volume of the Title Deed and commit the above fraud.

Causing the above act by the miscreants, we suffer the irreparable loss and injury.

Sir, I therefore, humbly request you to please enquire and investigate the above matter and take necessary legal steps against the miscreants who did such illegal act for his/their wrongful gain.
