Sir,

In producing herewith one accused named Gopal Saha (M/48) S/O- Bothkaran Saha of Vibekananda Nagar, PO-Salugara P.S- Bhaktinagar, Dist- Jalpaiguri along with following articles under proper seizure

1] 12 (Twelve) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml)

I, ASI Nitai Mandal of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one named Gopal Saha (M/48) to the effect that today on 09.07.2022 at 21.35 hrs while performing evening patrolling duty, received a source information that one person named Gopal Saha (M/48) is selling liquor in Hotel situated Checkpost, opposite Ektiasal FL OFF shop under Bhaktinagar PS without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction myself along with force had been to Checkpost, opposite Ektiasal FL OFF shop under Bhaktinagar PS to verify the veracity of the information. On reaching there and as identified by the source it found that one person was selling and storing at his shop. Subsequently, I along with my force cordoned his hotel and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the hotel. Further being searched the above noted seized articles were found in the said hotel. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further he stated that he is involved in selling and possessing of liquor without any valid license for last 06(six) months for his illegal gain. Then I seized and labeled the above mentioned liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person named Gopal Saha (M/48) S/O- Bothkaran Saha of Vibekananda Nagar, PO-Salugara P.S- Bhaktinagar, Dist- Jalpaiguri after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 21:55 hrs to 22:15 hrs at the spot and arrest issued memo of arrest at 22:17 hrs against him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Gopal Saha (M/48) S/O- Bothkaran Saha of Vibekananda Nagar, PO-Salugara P.S- Bhaktinagar, Dist- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
