Respected Sir,

With due respect I, Susmita Singha, S/O - Rajen Singha, W/O - Shyamal Barman @ Shyam, Resident of Thiknikata, P.O - Sushrutanagar, P.S - Matigara, Dist - Darjeeling, beg to inform you that I got married with one namely Shyamal Barman, S/O - Late Laxmin Barman, of Thiknikata in the year 2016 (13<sup>th</sup> December) and from our aforesaid marriage I have a school going minor son aged about 5 years.

It is pertinent to mention here my husband is a ambulance driver by profession of NBMC & H Emergency Gate Stand that after 2 years of our marriage my husband Shyam Barman started to beat me mercilessly by kicking, by pressing throat and by using the belt, Shows and he also used to keep me under lock and key and sometimes I was kept on starvation and now-a-days, my husband (Shyamal Barman) extremely increases his torture upon me and on every day he use to come home in midnight with heavy drunken condition and starts torturing upon me on every nights without any reason, it is important to mention here that he not only takes alcohol but also takes all types of Drugs Tablets and Ganja and after intoxication on every night he starts to torture upon me extremely from every midnight to till 4.00am or 5.00am.

It is to be noted here that my father has sent my husband to "Nesha Mukti Kendra" at Siliguri Salbari Bazar Jagriti Foundation for three months at his own cost but after returning from there, he again uses to take Alcohol on regular basis and tortures upon me, as he did previously.

It is to be noted here that on 06/07/2022 at about 11.30 my husband came home with full drunken condition and just after entering into the room he started to quarrel with me and on protest then he started to assault me mercilessly with his shoo and with a bamboo stick and on shouting I called my mother-in-law but seeing the situation my mother-in-law (Basanti Barman) did not came to rescue me from my husband and rather my mother-in-law assist my husband for doing torture upon me and when I somehow tried to flee away from my matrimonial house to my parental house then both my husband and my mother-in-law locked me in a room and then my husband again started to torture upon me inside the room till 4.00 am.

It is to be noted here that being unable to tolerate such type of torture upon me by my husband, on the very next day, on 07/07/2022 I somehow manage to flee away from my matrimonial house to my parental house with my minor son to save my life as well as the life of my minor son and after that I have treated in North Bengal Medical Collage and Hospital and taking Medicines as per prescription.

It is very unfortunate that there is a direct instigation of my sister-in-law namely Anita Barman, W/O - Nikhil Barman, and the husband of Anita Namely Nikhil Barman, S/O - (not Known) both are resident of Thiknikata, P.S. - Matigara, Dist. - Darjeeling and whenever my husband started to torture upon me at that time they always instigate over telephone to kill me and seeing the situation that my husband is beating me mercilessly, my mother-in-law always leaves the house and go to her daughter's house and spent night there and here I am facing my husband with worst situation along with my school going minor child.

It is to be noted here that all the other family members of my matrimonial house thinks that I have taken a contract to adjust or tolerate of my husband or their son or brother and they are joking to see my worst condition and they have no sympathy towards me rather they are using filthy languages towards me and my son and said the I could not do anything against them.

It is very unfortunate that yesterday on 08/08/2022 at about 11.00am my husband came to my parental house and started to threatening me with dire consequences that if I would not go to my matrimonial house in that event he will ruin my life and on protest when my father went out from our house at that time he uses filthy languages towards my family members and threatened my family members.

For the sake of my matrimonial life and for the better life of my minor son, I always tried to adjust with them but now it goes to extreme and worst situation for me and my son and it becomes unbearable for me as well as for my son.

Therefore, I am praying before you to enquire into the matter immediately and take a legal action against my husband as well as against all the family members of my husband as soon as possible.
