Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 357 dated 07.07.2022 and informed the fact to you. As per your kind direction and instruction myself along with CV/306 Biswajit Roy, Cv/824 Niru Kumar Mahata all of NJP PS, SPC left for Shrinagar, 70th More, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 2140 hrs hrs we arrived at 70th more, and being identified by the source I held raid at the shop of the said accused and managed to apprehended him.
