Subject - Complaint against RAJESH YADAV for pasting photos of my in Church gate & nearby market to malign my image in the society

Respected Sir,

I, Sangeeta Ekka, daughter of Policarp Ekka, R/o. Gangaram Tea Garden, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014 would like to state that I have lodged a complaint before Cyber Crime P.S. Siliguri Metropolitan Police on 12-11-2021 with regard to a fake Facebook profile. On 07-11-2021 at about 7.00 P.M. some of my friends inform me that some unknown person have opened a fake Facebook profile in my name "Sangeetaekka" with my photos pasted in the wall of the Facebook. Then lodged a Complaint before the Cyber Crime P.S. Siliguri Metropolitan Police on 12-11-2021. I then lodged a Complaint before the Commissioner of Police, SMP, Siliguri and it worked and the person stopped posting illegal photos & mobile number. Again on 26-05-2022, I came to know that one (1) new Facebook account has again been opened in my name "Sangeeta Ekka" with my photos posted in the wall of the Facebook account. The said fake Facebook account has been opened by **RAJESH YADAV**, son of Ram Eqval Yadav, R/o. Amdangi, Babu Basa, P.O. Gayaganga, P.S. Ghoshpukur outpost, District Darjeeling. Today 2022 at about 6.30 A.M. when I went to Church at Gaaganga I was shocked to see my photos pasted in the gate of the Church Gate. Later I heard that some of my photos have also been pasted in different places of Gangaram Market & Church More over bridge. I am sure that the said photos have been pasted by **RAJESH YADAV**. Thereafter when I and my aunty was standing near the cement shop at Gayaganga market, near hanuman mandir **RAJESH YADAV** suddenly came near me and physically assaulted me and my aunty and ran away. This has been his regular habit. **RAJESH YADAV** is always supported by his friends namely Amarjit Das & Udip Toppo, both of Gangaram Tea Garden, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014. Finding no other option I came before you for justice.

It is requested before you to kindly take necessary action against the persons involved so that he can be punished for the wrongful act.
