In producing herewith one accused person namely Sambhu Barman (46 yrs), S/o. Lt. Dharma Chand Barman of Dakshin Shantinagar, PO-Dabgram-II, PS-Bhaktinagar, Dist-Jalpaiguri along with the following seized articles as per proper seizure list:

1. 15(Fifteen) sealed Bottles of Himalayan Gold 60 Up Country Sprit each bottle containing 600 ML.

I, SI. Rakesh Debnath of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted accused person to the effect that today on 08.07.2022 at 16:30 hrs received a source information from Farabari, Adarshapally that the above noted person has gathered huge amount of liquor illegally for selling the same in the customer for his wrongful gain. This refers to Ambari Falakata Out Post GDE 283, dated 08.07.2022. I informed to O/C Ambari Falakata out post about the information. As per his kind instruction I along with, (1) C/- 625 Bhanendra Das and (2) NVF-130 Dhanadeb Roy both of Ambari-Falakata OP, Under NJP PS/SPC proceeds to Farabari, Adarshapally to work out the information. At 19:25 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at Farabari, Adarshapally and recovered the above noted articles from the possession of accused person namely Sambhu Barman (46 yrs) S/o. Lt. Dharma Chand Barman of Dakshin Shantinagar, PO-Dabgram-II, PS-Bhaktinagar, Dist- Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. Accordingly I seized the above noted articles from the possession of above noted accused person in presence of witnesses namely 1) Abhijit Majumder S/o. Lt. Ashim Majumder of Chakiavita, PO. Kamarvita, PS-NJP Dist-Jalpaiguri and 2) Gopal Malakar S/o. Swapan Malakar of Ashighar, PS. Bhaktinagar, Dist-Jalpaiguri after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made in between 19.35 hrs to 19:55 hrs. Then I arrested the said noted accused person u/s 41 Cr.P.C. and issued him Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Sambhu Barman (46 yrs) S/o. Lt. Dharma Chand Barman of Dakshin Shantinagar, PO-Dabgram-II, PS-Bhaktinagar, Dist-Jalpaiguri under proper section of law.
