Sir,

In producing herewith 01 (one) accused person namely Md. Jinnatullah Firdous (53) S/O Lt. Amanullah of Vill+P.O Chaspara, P.S- Kaliachak, Dist.- Malda (Not verified) along with the following seized articles under seizure as per seizure list :-

Total 03 (three) numbers of transparent plastic packet containing Total 305 (three hundred and Five) grams of said to be Brown Sugar Marked as follows :-

(i) One transparent plastic pouch containing total 101 (One hundred and one) Grams of said to be brown sugar and marked as "Exhibit-A".

(ii) One transparent plastic pouch containing total 102 (one hundred and two) Grams of said to be brown sugar and marked as "Exhibit-B".

(iii) One transparent plastic pouch containing total 102 (one hundred and two) Grams of said to be brown sugar and marked as "Exhibit-C".

(iv) one bag styled as 'Adhunik Bastralaya' and one Nestle Lactagen Packet.

(SI no I to III kept inside SI. No. IV) and seized from the exclusive and conscious possession of accused namely Md. Jinnatullah Firdous (53) S/O Lt. Amanullah of Vill+P.O- Chaspara, P.S- Kaliachak, Dist.- Malda

I, PSI Newton Biswas of New Jalpaiguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted 01 (one) arrested accused person namely Md. Jinnatullah Firdous (53) S/O Amanullah of Vill+P.O- Chaspara, P.S- Kaliachak, Dist.- Malda to the effect that today i.e on 09.07.2022 at about 20.05 hrs received a specific source information that 01(one) person was standing at in front of Pather Sathi , Passenger Shed under PS- N. P, Dist.- Jalpaiguri with a bag containing huge quantity of Brown Sugar for delivering the same to their designed customers. Accordingly, the matter was diarized in General diary vide NJP PS GDE No 458 dated 09.07.2022 and subsequently informed the matter to you and being directed, myself along with PSI Pradeep Deyali, VP/08 Laxman Roy, VP/13 Jamirul Islam and others all of NJP PS, SPC and left for in front of Pather Sathi , Passenger Shed under PS- NJP, Dist.- Jalpaiguri by Govt. Vehicle along with investigation kit to verify the veracity of the information in hand vide NJP PS GDE No 459 dated 09.07.2022 and M.C.C. No. 1912/22 dated 09.07.2022 . Under this circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender.

On the way to in front of Pather Sathi , Passenger Shed under PS- NJP,, I contacted two persons namely (1) Buddhadeb Saha (26) S/O Arun Saha of Surya sen Colony, Block- A, W/No. 34, P.S- NJP, Dist.- Jalpaiguri and (2) Somya Bikash Ghosh (40) S/O Lt. Jyoti Prokash Ghosh of Purba Dhantala, P.S- NJP, Dist.- Jalpaiguri, and make them aware about the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter, we along with the independent witnesses noted above reached at in front of Pather Sathi , Passenger Shed under PS- NJP, Dist.- Jalpaiguri at 20.45 hrs and being pointed by the source approached towards 01 (one) person standing at in front of Pather Sathi , Passenger Shed under PS- NJP and apprehended him. Thereafter, we disclosed our identity and inform them regarding the information in hand and stated him that he will be searched in person for the said purpose.

On being asked he disclosed his identity as noted above and admitted that he has illegally possessed brown sugar for selling the same to his designed customers as per their requirement. I then gave him option in writing whether he wanted to be searched in presence of an Executive Magistrate or by any GAZETTED Officer and they agreed to be searched in presence of any one of the above. Accordingly, I informed the matter to the Officer-In-Charge, NJP PS as per his kind order, I informed the fact to Shri Santanu Tarafder, WBPS, ACP (AP), Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, of SPC for the day regarding interception of the accused person suspected to be possessed Brown Sugar and requested him to come at in front of Pather Sathi , Passenger Shed under PS- NJP, Dist.- Jalpaiguri to remain present and to supervise the search and seizure.
