With due respect, I am producing herewith the arrested accused persons namely (i) Suman Sah (28) s/o Firoj Sah of Samelii, PS-Katihar, Bihar (ii) Hriday Sah (42) s/o Vrahmadev Sah of Chakala Maulananagar, Sarelii, Dist.- Kathihar, Bihar,(iii) Ram Kumar Sha (35) s/o Shankar Shah of 65 Dhanya New Tola, Nayatola, PS- Kathihar, Bihar (iv) Deepak Sah (36) s/o Sitaram Sah of Decodar, PO-Deodanr, P.S- Deodawar, Godda Jharkhand.(v) Munna Mandal (33) s/o Jiten Mandal of Khair, Lalchand, Khaira, PS- Ayoudhaganj Bazar, Dist.- Kathihar, Bihar (vi) Jitendra Sah (32) s/o Sudhir Sah of Kharia, Lalchand, PO- Samelii, PS- Katihar, Bihar (vii) Monu Roy (21) s/o Rajesh Roy of Shantipara PS- NJP. PSI Newton Biswas of NJP PS, Siliguri Police Commissionerate beg to state that on 11.07.2022 at 01-5 hrs received a secret source information that that a gang of miscreants come at near Netaji More, PS- NJP, Dist.- Jalpaiguri with deadly weapons and assembled there and making preparation for committing dacoity at Netaji More PS-NJP, Dist.- Jalpaiguri. Accordingly, I diarised the fact in General Diary vide NJP PS GDE No 513 dated 11.07.2022 and informed the fact to you as well as Asstt Commissioner of Police, East -II, SPC about the information. I also informed the fact to night RT Van officer and requested them to come to Netaji More to accompany with us. At 0155 hrs we arrived at near Netaji More under PS- NJP, Dist.- Jalpaiguri and ambush there. After a few time RT Van officer along with force came to near Netaji More and accompany with us. At about 0225 hrs as indicated by the source we noticed that 10/11 persons assembled in a dark place near Netaji More, PS- NJP, Dist.- Jalpaiguri and they were whispering in a very low voice. Accordingly, we cordoned the place properly and approach towards them very slowly and carefully but seeing the police party they started to flee away but we the police party managed to apprehended 08 (Eight) of them with deadly weapons in their possession. On interrogation the apprehended accused persons disclosed their name and identity as noted above.

During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presene in middle of the night with deadly weapons. Finally they disclosed that they assembled there for committing dacoity at Ambikagar area. Accordingly, I seized the above noted weapon of offence from their possession under proper seizure list and arrested the above noted 07 (Seven) accused persons under proper memo of arrest and observing all the formalities of arrest and brought them to NJP PS. The search seizure and arrest made in between 0235 hrs to 0305 hrs on 11.07.2022

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (i) Suman Sha (28) s/o Firoh Sah of Samelii, PS-Katihar, Bihar (ii) Hriday Sah s/o Varhmadev Sah of Chakala Maulananagar, Sarelii, Sist.- Bihar,(iii) Ram Kumar Sah s/o Shsnkar Sah of 65,Dhanya New Tola, Nayatolw, PS-Katihar, Bihar (iv) Deepak Sah s/o Sitara, Sah of Decodar, PO-Deodanr,Godda Deodawar, Jharkhand,(v) Munna Mandal (33) s/o Jiten Mandal Khaira of Lalchand, Khaira, PS- Ayoudhaganj (vi) Jitendra Sah s/o Sudhir Sah of Kharia, Lalchand, PO- Samelii, PS- Katihar, Bihar (vii) Monu Mandal s/o Jiten Mandal of Shantipara PS- NJP, Dist.-Jalpaiguri (viii) Bappa Mallik (28) s/o Partitosh Mallik of Shantipara, Dist.- NJP, Dist.- Jalpaiguri and others and arrange for its investigation.
